RE: Opposition to S.B. 907 Relating to Vaccination Guidelines

Testimony from Sukwah Lin Senate Bill 907 Relating to Vaccination Guidelines Committee: House Judiciary Committee Hearing Date: Friday, February 27, 2013 Hearing Time: 2:00 p.m. Hearing Location: Room 325

Dear Members of the House Judiciary Committee,

I strongly **OPPOSE** the Senator bill 907. I ask that an amendment be added that vaccination should never be mandated for all adults and children. Better yet, I ask that you DO NOT pass this bill at all.

There are a couple of events happened last year that enable me to tell you NOT to try so hard and in such a big hurry to make people adhere to the national standard of vaccination.

First of all, FDA, the government agency that regulate and approved the vaccines that are given to the public, is now under investigation by the Congress for spying on the emails that whistleblowers i.e. the scientists in FDA had with Congress. In the past two years, a group of 11 extinguished scientists and physicians explained that the agency used intimidation and coercion tactics as a means of getting FDA experts to approve unsafe and defective medical devices. Important health and safety regulatory requirements were sidestepped, illegitimate safety evaluation procedures were used and inaccurate scientific and technical data were relied upon in approving these medical devices. According to Dr. Ronald Kavanagh B.S. Pharm., Pharm.D, Ph.D., an FDA drug reviewer states, "There is also irrefutable evidence that managers at CDER (Center for Drug Evaluation and Research) have placed the nation at risk by corrupting the evaluation of drugs and by interfering our ability to ensure the safety and efficacy of drugs. While I was at FDA, drug reviewers were clearly told not to question drug companies and that our job was to approve drugs...If we asked questions that could delay or prevent a drug's approval-which of course was our job as drug reviewers – management would reprimand us, reassign us, hold secret meetings about us, and worse."

Secondly, two whistleblowers scientists who used to work for Merck, filed lawsuits against the drug company for hiding the declining efficacy of MMR shot. For more than 10 years, Merck allegedly "knowingly falsified its mumps vaccine test data, spiked blood samples with animal antibodies, and sold a vaccine that actually **promoted** mumps and measles outbreaks." Merck ripped off governments and consumers who bought the vaccine thinking it was "95% effective".

We can no longer say that vaccines are safe, We also can no longer trust the clinical trials that so-called "proved" the safety of vaccines.

On the other hand, there Is a very large and ongoing study out of Germany involving over 17,000 children, including newborns up to those 19 years of age, has found that vaccinated children have up to 5 times the rate of diseases and disorders compared to the same age group who has not been vaccinated. In every single disease category, unvaccinated children fared far better than vaccinated children in terms of both disease prevalence and severity. In other words, the *evidence suggests that vaccines are neither effective nor safe*. It is consistent with what the scientists that are involved with the lawsuits are saying.

This study confirms the results of earlier independent study surveys that produced similar conclusions in the vaccinated vs unvaccinated issue.

In this study, the numbers are even more divergent for asthma and chronic bronchitis, where vaccinated children are about eight times more likely than unvacinnated children to develop such respiratory problems. Vaccinated children are also far more likely to develop hyperactivity, hay fever, and thyroid disease, with their likelihood 3 times, 4 times, and a shocking 17 times higher, respectively, compared to unvaccinated children.

This study also shows that in this population, vaccinated children are about 2.5 times more likely to develop severe autism compared to unvaccinated children. The four unvaccinated children who reported severe autism all tested high for heavy metals, including mercury, which further indicts vaccines and their disease-causing ingredients.

I would like to point out the most recent statistics published by CDC for their survey done in 2008. About 1 in 6 children in the U.S. had a developmental disability in 2006-2008, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy and autism. About 1 in 88 children has been identified with autism spectrum disorder (ASD). The rate is found to increase drastically every time they did the survey, which is every 4 years. According to CDC, prior to 1980, autistic disorder was thought to be rare, affecting approximately 1 in every 2,000 children. Autism costs United States \$137 billions per year, which suggest a three-fold increase in less than a decade.

About 1 in 10 children had asthma, the highest of all the groups. About 1 in 12 adults had asthma. The rates are growing every year. Asthma costs the United States about \$56 billions in medical costs, lost school and work days, and early deaths in 2007.

These kind of statistics is very consistent with the fact that CDC is requiring our children to take more and more vaccines every year. It is also very consistent with the lawsuits that I mentioned earlier, that we can no longer say that vaccines are safe. In 1980, the number of vaccines is 7 for a two year old, possible number of injections at a single visit is 2. Now before kindergarten, a child may have over 50 doses of 14 vaccines, 26 doses in the first year, up to 12 in one single visit.

According to Dr. Harold Buttram, "...in the case of toxic chemicals two compounds together may be 10 times more toxic than either separately, or 3 compounds 100 times more toxic."

According to Dr. Boyd Haley, "A single vaccine given to a six-pound newborn is the equivalent of giving a 180 pounds adult 30 vaccinations on the same day. Include in this the toxic effects of high levels of mercury, aluminum and formaldehyde contained in some vaccines, and the synergist toxicity is increased to unknown levels."

One should really examine the ingredients in vaccines, which include mercury, aluminum and a whole hosts of other toxins. *IT IS A LIE THAT WE CAN PROTECT OUR PEOPLE AND ENHANCE THEIR HEALTH BY GIVING THEM TOXINS*.

It is costly to give vaccines. It is even more costly to take

care of the consequences of vaccination, monetary-wise (as I have already quoted) and emotionally and physically speaking. It is the quality of life that is the most important.

At last, I want to point out to you in my display the collection of pictures of children and adults who have never been vaccinated. You can judge for yourself and see if these people seem miserable.

To summarize, I strongly oppose the Bill 907. I strongly oppose giving the Department of Health authority to adopt, amend, or repeal the list of specific vaccines and to adopt, amend, or repeal, as rules, the immunization recommendations of the United States Department of Health and Human Services, Advisory Committee on Immunization Practices, as they apply to the list of specific vaccines.
