# HB 92 Relating to Voting

#### Chair Rhoads, Vice Chair Har and Committee Members

Our chapter of 500 retired and currently serving officers of the Uniformed Services strongly supports HB 92, which provides that a military-overseas ballot of an eligible voter not be deemed invalid solely because the voter became ineligible after casting the ballot.

This measure will allow military-overseas voters the same privileges as provided for any other eligible voters who later become ineligible to vote after casting the ballot. We note that while Hawaii has a commendable record of dealing with military and others voting while overseas, when it comes to voting procedures, it is only fair to provide specifically for this situation of subsequent ineligibility, however unlikely it is to occur.

# **RELATING TO VOTING**

Chair Rhoads and members of the House Committee on Judiciary, thank you for the opportunity to testify on House Bill No. 92. The purpose of this bill is to provide that the ballot of an absentee or military-overseas voter is valid even if the voter becomes ineligible to vote after casting the ballot. The Office of Elections supports the intent of this bill.

Election officials must have official proof of a person's death before they can be removed from the voter registration rolls and deemed ineligible to vote. This frequently occurs in the form of reports from the Department of Health. Given the short time between casting an absentee mail ballot and the actual election, deaths during this time, generally cannot be officially confirmed, therefore we cannot invalidate the ballot.

Additionally, the Office of Elections notes that administratively there is no consistent means by which an absentee ballot that has been cast can be readily segregated and retrieved from other properly cast ballots so as to be invalidated under HRS § 15-13. The present bill ensures the consistent treatment of all ballots that were cast by voters who were eligible at the time of casting their ballots, but who subsequently became ineligible, by providing that their ballots will be deemed valid.
