Chairperson Wooley and Members of the Committee:

Thank you for this opportunity to provide testimony on House Concurrent Resolution 11, requesting the establishment of a task force to examine the opportunities for mobile slaughterhouses in the State of Hawaii.

The Hawaii Department of Agriculture recognizes the challenges of small livestock producers with the lack of available slaughter facilities or the lack of slaughter capabilities within a practical distance from the production area.

The Department supports the intent of this resolution; however, the resolution does not include participation from other livestock industries, such as, hog, poultry, sheep and goats. In addition, the resolution limits the discussions on the potential funding, management and operation, rural development and financial sustainability of a mobile slaughterhouse, which is restricted to only the slaughter of animals. There are other critical issues, such as cold storage and further processing facilities, which is needed to market the slaughtered carcasses.



The Department is requested to organize the task force with participation from other county planning and research and development personnel. This is a major undertaking and no funds have been appropriated to conduct the task force.

Chair Wooley, Vice Chair Onishi and Members of the Committee:

My name is Alan Gottlieb, and I am a rancher and the Government Affairs Chairperson of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council <u>supports the intent</u> of HCR 11, but we want to point out that several years ago, the Agribusiness Development Corporation did an extensive study of the feasibility of a mobile slaughterhouse and had funds appropriated to purchase one as a pilot project for use in several counties, including Kauai and Honolulu, but the funds were never released by then Governor Lingle. We humbly suggest that if a task force is formed, they use that prior information as a starting point.

We appreciate this opportunity to provide testimony on this matter.
