Chairperson Wooley, Vice Chair Onishi and Members of the Committee,

Thank you for the opportunity to testify on HCR 140/HR 110. The Department supports the intent of this resolution but would request that funding be identified that would be used for the grant program.

There are grants currently offered by the state that are available to farmers who implement natural farming. The Specialty Crop Block Grant Program, for example, is offered to projects that solely enhance the competiveness of specialty crops and a proposal for the farming of Vietnamese Taro and Thai Basil would be eligible. The Western Sustainable Agriculture Research and Education is another federal grant program that is currently offered to farmers and associations.

A grant program specific to the Cho global natural farming methodology could be implemented by the Department should funding be identified.
