The Governor's Office supports this resolution, which underscores transformational work underway across the state to improve health and health care. This resolution makes important statements about the obesity crisis and expanding and strengthening our health information technology infrastructure as an indispensable tool to address it. Further, the resolution recognizes the essential work begun by the Hawaii Health Care Project, which is aligned with these goals.

We are pleased to report that our office was recently awarded a federal grant for health care transformation planning. This effort, which is expressly designed as a public-private endeavor, will support the next phase of the Hawaii Health Care Project as it addresses improving our health care delivery system, including behavioral and oral health; workforce development; standardizing insurer approaches to needed change; and health information technology. Our intent for the latter is to devise ways to expand the meaningful use of electronic health records and exchange of clinical information and to develop strategies to aggregate, analyze, and use health information to continuously improve our healthcare system. The Hawaii Health Care Project's efforts will also include strategies for developing and sustaining health IT systems and other aspects of innovation, which will certainly include identifying and seeking all appropriate federal funding opportunities.

We look forward to providing periodic updates to this body as our work progresses and we thank you for the opportunity to testify on this concurrent resolution.

Testimony in Strong Support

My name is Virginia Pressler, MD, MBA, Executive Vice President and Chief Strategic Officer for Hawai'i Pacific Health (HPH). HPH is a nonprofit health care system and the state's largest health care provider anchored by its four nonprofit hospitals: Kapi'olani Medical Center for Women & Children, Pali Momi Medical Center, Straub Clinic & Hospital and Wilcox Memorial Hospital on Kauai. HPH is committed to providing the highest quality medical care and service to the people of Hawai'i and the Pacific Region through its four affiliated hospitals, 49 outpatient clinics and service sites, more than 5,400 employees and 1,300 physicians on staff.

I am writing in strong support of HCR 21, which requests the state of Hawaii to support the efforts of the Hawaii health care project (HHCP) and the Hawaii health information exchange (HHIE) to implement an efficient and effective, integrated, technology-based healthcare information system.

To address the problem of obesity in Hawaii, the healthcare system needs an integrated information technology system that provides an efficient means to share clinical and other healthcare-related data about the population residing in various registries and surveillance systems in the State. This resolution would support the efforts of a public-private partnership to include those with shared interests in providing data into and receiving data through the system. Additionally, the resolution asks that all State agencies that collect and maintain healthcare-related data and information cooperate with the HHCP and HHIE's efforts to develop and implement the technology-based healthcare information system. The resolution requests that the HHCP and HHIE develop a financial sustainability model to maintain the technology-based healthcare information the system to fairly share in the financial responsibility to maintain that system, and that the State should maximize efforts at applying for and receiving federal funding for the system.

This measure thus provides the means by which the use of information technology will improve the efficiency of access to a patient's healthcare information, and thus improve the efficiency and quality of patient care. We ask that this Committee pass the measure.
