My name is Harvey M. Nakamoto Jr. and I am a former competitive boxer. I am also an attorney licensed to practice in Honolulu, Hawaii. I am writing in support of H.C.R. No. 30 and H.R. No. 14.

I strongly support H.C.R. No. 30 and H.R. No. 14 because I believe that involvement in boxing helps youth develop discipline, self-confidence, and respect for others like nothing else can. The vast amounts of time, discipline, and sacrifice that goes into to preparation for a short 6 minute bout is what I believe separates boxing from any other sport or activity. Boxing teaches participants that opportunities are limited and that as such one must work hard and be prepared to make the most of any opportunity one is presented with.

My personal involvement with boxing began in 1997 shortly after I graduated from Aiea High School. In a short time training and competing in boxing changed me from a person who barely graduated from a public high school to a dedicated student that graduated with honors from Leeward Community College and then with distinction from the University of Hawaii at Manoa.
