I am a National Board Certified Teacher. As a former 5th grade teacher and Kindergarten teacher (I am now a Curriculum Coordinator at Ewa Makai Middle School), I believe civics education begins in Kindergarten with class rules, school rules, home rules, and understanding the roles of police, the fire dept. etc. and every citizen. It is vital that we help our keiki understand the value and purpose of government because it is VITAL to our democracy. I taught We the People in 5th grade, connecting it to our ELA standards for persuasive writing and to our social studies standards regarding colonies and The Revolutionary War, but it SURE would have made it easier for other teachers to make the connection if we had more civic standards. My 5th graders were ENGAGED in civic action. They even spoke at a town meeting to change a dangerous traffic situation in front of our school and now, several years later, these same students are active in their schools in student council, Leadership, and their communities. Some of my former students are now in college yet, they are fighting for a/c in public schools for the students who came after them. They care; they "get it", and we need to promote this type of civic engagement through our curriculum standards in our schools. Other reasons: 1. As a teacher in Hawaii public schools the past 10 years I witnessed a severe lack of focus on civic knowledge, skills, and dispositions in our public schools As a 8th grade teacher for 7 years I continually saw my 8th grade students come into the classroom with not even the most basic knowledge on how government works. They had no idea what the Declaration of Independence was or the foundational reasons for the American Revolution information they were suppose to receive in elementary school. Now as I te acher high school I see students still lack skills and knowledge and by 11/12th grade their apathy and disdain for government has settled in. The bottom line - we need to make a more concerted effort to teach and reinforce a strong civic education curriculum in the K-12 setting. What's happening now with testing such as the multiple choice End of Course Assessments in United States History and soon coming World History is teachers moving away from strategies that require the inquiry, discourse, dialogue, and problem solving skills, and project based strategies needed to be an active citizen in a representative democracy. Therefore, I urge you to please support HCR 46 and any other further efforts that require the Hawaii Department of Education to make a stronger effort to make civic education an integral part of the K-12 education experience.
