Comments: While I support the intent of the bill, please consider making the following changes: 1) the reso is written for the creation of a statewide task force, yet it includes a representative from the Kaloko Honokohau National Park even though they are 1) a federal agency, and b) only care about one Small Boat Harbor (Honokohau), and c) there are other federally designated areas near other harbors that should be added if Kaloko Honokohau has a seat. I'd suggest that they be dropped from the list, because their interest is limited to only one small boat harbor facility. 2) perhaps OHA might be a more relevant organization to have a seat on this task force? I don't think Hawaiian Homes Commission manages land adjacent to all small boat harbors, but OHA benefits from revenues generated by all small boat harbors. 3) The inclusion of "Hawaii fishing and boating associations" is likely to be inclusive of tenants of state harbors and marinas. I would strongly urge that this Resolution require that the DLNR form this task force by a specific date and that they be asked to report on the progress of the task force by some date early in the next legislative session. Without a deadline, they might and probably will defer the creation of this valuable body for a long, long time. In consideration of HOUSE CONCURRENT RESOLUTION 49 REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ESTABLISH A SMALL BOAT HARBOR MANAGEMENT TASK FORCE.

House Concurrent Resolution 49 requests the Department of Land and Natural Resources (Department) to establish a small boat harbor management task force. **The Department opposes this resolution.**

The Department respectfully disputes that there is inadequate management of the state boating facilities. The Small Boat Harbor Program is managed by the Department's Division of Boating of Ocean Recreation according to the Hawaii Revised Statutes (HRS) and Hawaii Administration Rules (HAR). The Department is aware of past audit findings and has addressed the deficiencies.

The Department notes that major progress has been made within the state boating facilities program that includes major CIP initiatives, amendments to the HAR that make management of the facilities more effective, leasing of fast lands that will generate substantial revenue to the Department, implementation of insurance requirements, setting mooring fees at appraised value to ensure facilities operate at breakeven, implementing mandatory vessel education requirements, establishing parking plans, developing the on-line Boating Accounts Receivable System, and vessel registration system.

The Department is bound by the HRS and appreciates the Legislature's support over the last several years that has resulted in the substantial improvements to the program. The Department requests that the Legislature support its initiatives, such as Senate Bill 1161, Senate Draft 1, House Draft 1, so it can continue improve and streamline the State Boating and Ocean Recreation Program.
