Aloha Chair Espero, Vice Chair Baker and Committee Members,

I am Kathleen A. Eisenbrey, chair of The Hawaii Women's Military Veterans Task Force. On 25 March 2013, 9 of 13 board members voted in support of HCR60 HD1 PROPOSED. According to our By Laws, this majority enables the Hawaii Women's Military Veterans Task Force to strongly support this measure.

Senate Resolution No. 6 S.D.1. directed the United States Department of Veterans Affairs (VA) and the Hawaii Office of Veterans Services to develop comprehensive programs and services to address the needs of women veterans and women serving on active duty orders. The Task Force submitted a report to the 2013 Legislature presenting an analysis of the challenges faced by women veterans, including Military Sexual Trauma (MST), homelessness and joblessness along with PTSD.

The Task Force has conducted a preliminary assessment of services currently available; noteworthy gaps in services include an inherent lack of coordination between civilian services, Tricare and VA systems. The Task Force recognized the need for accurate data to properly estimate the number of women serving on active duty orders in Hawaii, as well as statistical data regarding the number of women veterans and women serving on active duty orders who experience MST, homelessness, joblessness, and PTSD.

The Task Force has made a number of recommendations, including the creation of a Military Women's Coordinator.

This proposed Resolution will provide support for the establishment of a Veteran Women Services Coordinator position within the Office of Veterans Services. This coordinator could aid with the process of helping an excess of 12,000 women veterans by assisting OVS to identify and address the unique needs of women veterans, integrate services, utilize the Task Force's recommendations, and synergize various Federal and State agencies to influence health policy.

The Task Force requests the addition of a Reservist (Air Force, Army or Navy) in addition to the current criteria of a Hawaii National Guardsman (Air or Army).

Aloha Chair Espero, Vice Chair Baker and Committee Members,

I am Rachel James, Secretary of The Hawaii Women Military Veterans Task Force and, we are in strong support of this measure.

The Task Force was formed by the Legislature in 2012 to address the needs of active duty and veteran military women in Hawaii. We submitted a report to the 2013 Legislature that detailed preliminary findings concerning our women warriors. We found that military sexual trauma (MST) is rampant in the armed services, that homelessness and joblessness along with PTSD are some of the major problems that our women face.

We began an assessment of services that are currently available and noted some gaps, most notably a lack of coordination between civilian services and our VA systems. We found that specific training at our medical schools does not include training for MST. We also recognized a need for more data on the numbers of military women in Hawaii, as well as data on the aforementioned issues of MST, homelessness, joblessness and PTSD.

We made a number of recommendations as to the way forward. Among them was the creation of a Military Women's Coordinator.

This proposed Resolution would pave the way for the establishment of a Veteran Women Services Coordinator position within the Office of Veterans Services. This coordinator could aid with the process of helping the approximately 12,000 women veterans in Hawaii to move forward in their lives. He or She can help the OVS to collect data, integrate services and move forward on the Task Force's recommendations.

Hawaii's military women have served our nation often at great cost to their health, their lives and too often to their human dignity. As a state we need to recognize their sacrifice by addressing their needs, in and out of the service.

We also request that Reservist (Air or Army) be added to list of military organizations from which a candidate may be selected.
