In consideration of HOUSE CONCURRENT RESOLUTION NO. 65 REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ESTABLISH A TASK FORCE TO ASSIST WITH THE DEVELOPMENT OF RULES TO ENSURE GREATER PROTECTION OF THE STATE'S OCEAN RESOURCES

House Concurrent Resolution 65 requests the Department of Land and Natural Resources (Department) to establish a task force to assist in the development of rules. <u>The Department</u> appreciates the intent of the measure and offers the following comments:

During the normal course of rule development, a variety of complex issues arise that require the Department to consult with knowledgeable individuals, agencies or organizations with expertise in these subject matter. The Department also consults with those who would be most affected by the passage of such rules to better understand the potential impacts that such changes will have on them. This knowledge provides us with the best available information to help us make the best management decisions. With each new possible rule comes a new set of individuals with the expertise to help us.

The Department already consults with a number of organizations to better manage the State's resources. The Aha Moku Advisory Committee is established in statutes to provide the Department with advice from the native Hawaiian perspective to ensure that we are mindful of the traditional and cultural practices. For example, the Kauai Aquatic Life and Wildlife Advisory Committee provides us with a local perspective from Kauai fishers and hunters for rules that would impact Kauai. We depend on these organizations and individuals to ensure that the rules make sense, create both maximum conservation and economic benefits and are enforceable.

The Task Force approach may be useful when dealing with a specific issue or focusing in a specific area where the members of the task force posess specialist knowledge on that subject matter, but may have a more limited use on wider, more broad reaching, matters.

Testimony of The Nature Conservancy of Hawai'i Opposing HCR 65 Requesting the Department of Land and Natural Resources to Establish a Task Force to Assist with the Development of Rules to Ensure Greater Protection of the State's Ocean Resources House Committee on Ocean, Marine Resources and Hawaiian Affairs Wednesday, March 12, 2014, 9:30AM, Room 325

The Nature Conservancy of Hawai'i is a private non-profit conservation organization dedicated to the preservation of the lands and waters upon which life in these islands depends. The Conservancy has helped to protect nearly 200,000 acres of natural lands in Hawai'i. Today, we actively manage more than 35,000 acres in 11 nature preserves on Maui, Hawai'i, Moloka'i, Lāna'i, and Kaua'i. We also work closely with government agencies, private parties and communities on cooperative land and marine management projects.

The Nature Conservancy opposes HCR 65 because it would establish a small, politically appointed task force that would have a disproportionate influence on Hawai'i marine rules without direct knowledge of the particular resources, people, or traditions of the communities affected by those rules. For these same reasons, we are also opposed to HB 709 HD2 that was passed last week by the House.

Communities and families from all across the islands have seen near shore resources declining dramatically because of a lack of management in the past. They see it as their responsibility to restore and take care of those resources. So, for several years, communities like Hā'ena, Mo'omomi, Kīpahulu, Ka'ūpūlehu and Miloli'i, to name a few, have been working with the DLNR to develop the management structures based on traditional knowledge and practices specific to their place needed to recover their fisheries and other marine resources. Working within the existing law and administrative rulemaking process, they have conducted public outreach meetings, and consulted in groups and individually with community members, fishermen, the Aha Moku Councils, Hawaiian Civic Clubs, government agencies, and many others whose thoughts and experience have been included in management plans.

These communities are committed to ensuring the long-term health of their fisheries and coastal resources because they have depended on them for generations and will for generations to come. A small, politically appointed task force is neither needed nor is it appropriate that it would take precedence over generations of knowledge, history, and many years of hard work by the families and community members who are committed to restoring abundance for generations to come.

Instead of creating this task force, we ask that you simply acknowledge and support these community-based efforts.

Testimony Before The House Committee on Ocean, Marine Resources and Hawaiian Affairs <u>IN OPPOSITION TO HCR 65</u> Wednesday, March 12, 2014, 9:30AM, Room 325

My name is Kevin Chang and I am the Executive Director of Kua'āina Ulu 'Auamo (or KUA). KUA works to empower grassroots rural and Native Hawaiian mālama 'āina groups to celebrate their places and pass on their traditions to better Hawai'i and achieve 'āina momona— an abundant, productive ecological system that supports community well-being. KUA employs a community-driven approach and facilitates a network of more than 25 communities across ka pae'āina o Hawai'i (the Hawaiian archipelago) called E Alu Pū (moving forward together).

KUA opposes HCR 65 because it would establish a small, politically appointed task force to work with DLNR to develop rules that will affect many of the communities we work with. Moreover it will do so without the direct benefit of their unique knowledge of the resources, people, or traditions of their place. For these same reasons, KUA is also opposed to HB 709 HD2 passed last week by the House. A centralized and politically-appointed task force should not take precedence over generations of place based knowledge, history, and many years of hard work by the families and community members committed to restoring abundance for future generations.

On its face much of the resolution's language is commendable and sets forth important and laudable values and goals for our state. However, in practice we believe it will disregard and contravene the great efforts expended by communities who have diligently worked with the state, some now for over 10-20 years to develop community based subsistence fishing areas and rules pursuant to HRS 188-22.6, 22.7 and 22.9.

As an example, the community of Hā'ena, Kaua'i worked very long and hard within the existing law and administrative rulemaking process and are at the cusp of establishing their rule package. They set up a community fishery committee, driven and inspired by kupuna experts in the Konohiki practices of the ahupua'a and moku. They conducted outreach and created a management plan over the past 8 years. They developed rules and endured a plethora of drafts working with the state over the past 3 years. Over 60+ public outreach meetings, and consultations in groups and individually with community members, fishermen, the Aha Moku Councils, Hawaiian Civic Clubs, OHA, DLNR's Division of Aquatic Resources, and many other groups and individuals were held.

Our communities are committed to ensuring the long-term health of our fisheries and coastal resources because they have depended on them for generations. Instead, we ask that you support the community efforts arising from the kua'āina up. These efforts are founded on the knowledge of kūpuna, kama'āina 'ohana, and their traditional and customary practices.
