The Department of Education (DOE) supports this resolution and agrees that there is a viable connection between the State and the provinces of the Republic of the Philippines and that outbound foreign exchange opportunities, in particular, will help to increase global-mindedness and to strengthen college and career preparation and 21st century competencies and leadership of Hawaii's students.

Therefore, the DOE is willing to explore mutually beneficial options and partner with Filipino community organizations to develop and coordinate a program with schools in any of the provinces in the Republic of the Philippines with which the State currently has a State-Province relationship, subject to the availability of funding support and staff resources.
