The effects of such an exchange program will spill into other areas as well, as in increased cultural, economic and business relations, which will redound to the good of both countries.

Thank you for the opportunity to submit testimony in support of HCR 71 which requests the Department of Education to support a student exchange program for students in Hawaii public schools and students in provinces in the Republic of the Philippines with which the State has state-province relationships. My name is Serafin Colmenares Jr. and I am the executive director of the Congress of Visayan Organizations (COVO), the umbrella of Visayan organizations in the state of Hawaii. I strongly support this concurrent resolution with a proposed amendment to include the Province of Negros Oriental, which signed a sister state-province relationship with Hawaii in 2011 in the list of Philippine provinces mentioned in the resolution. The amendment is as follows:

Line 21: "Negros Oriental, Ilocos Norte, Ilocos, and Pangasinan..."

Hawaii's Visayan community has been instrumental in establishing State-Province relationships between Hawaii and the Provinces of Cebu and Negros Oriental in the Philippines, in addition to sister city relations between Honolulu and Cebu City and between the County of Hawaii and the City of Ormoc in the Philippines. We believe that having this student exchange program would be very beneficial not only in expanding the horizons of participating public school students and increasing their knowledge of other peoples and cultures, but also in promoting international understanding and peace between nations. The effects of such an exchange program will spill into other areas as well, as in increased cultural, economic and business relations, which will redound to the good of both countries.

Hawaii has a large Filipino community, and having such a student exchange will be beneficial for those Hawaii-born Filipinos who desire to rediscover their roots and understand their culture.

I urge the members of this committee to pass this resolution.

## TESTIMONY OF THE STATE FOUNDATION ON CULTURE AND THE ARTS TO THE HOUSE COMMITTEE ON VETERANS, MILITARY AND INTERNATIONAL AFFAIRS AND CULTURE AND THE ARTS ON MARCH 27, 2013

#### HCR 71 / HR 55

Chair Takai and members of the Committee, I am Eva Laird Smith, executive director of the State Foundation on Culture and the Arts. I am pleased to support House Concurrent Resolution 71 / House Resolution 55, provided passage of these resolutions do not replace or adversely impact priorities indicated in the Executive Budget.

The State Foundation on Culture and the Arts strongly advocates for cultural appreciation and understanding as a way of increasing global peace. An effective way to promote international relations is to impress upon our future citizens and leaders an awareness of cultural diversity; to experience firsthand how our values and customs are different and similar; in short, an appreciation of the universal.

Technology has brought us closer to other countries in virtual time, space and communication. Yet, there is no substitute for the actual experience of being in a place and in the presence of real people to encourage learning. This is especially so with cultural exchange. For culture to be real, it must be lived.

The 2010 census shows the Filipino population in Hawaii surpassing the Japanese as the state's largest ethnic group. Having

arrived here to work the plantations back in 1906, Filipinos have grown Hawaii's diversity and industry and since then, have added significantly to our skilled and professional work force.

HCR 71 / HR 55 will provide rare opportunities for educational exchanges and the sharing of experiences between the youth of Hawaii and the youth of the Philippines through the richness of our sister-city relationships. Only good things can result from such an initiative.

Our youth are our future. Hawaii's history, society, political landscape, and cultural diversity have been forged from the citizenry of our state over centuries and generations of migratory peoples that have found home here. Years ago, only diplomats traveled to represent their governments. Today, these younger ambassadors carry with them the gifts of two cultures: the future of Hawaii and the Philippines.
