HOUSE CONCURRENT RESOLUTION NO. 79 REQUESTING THE CHAIRPERSON OF THE BOARD OF AGRICULTURE TO CONVENE A TASK FORCE ON FISH LABELING

Chairpersons Wooley and Tsuji and Members of the Committees:

Thank you for the opportunity to testify on House Concurrent Resolution 79. The purpose of this resolution is to request the Chairperson of the Board of Agriculture to convene a task force to determine whether the State should adopt laws on fish labeling in order to distinguish fish that are line-caught from fish that are net-caught or raised on farms.

In 2005, the U.S. Department of Agriculture (USDA) established country of origin labeling (COOL) rules, which require retailers to notify their customers by labeling seafood which identifies the country of origin where it is from and whether it was farm raised or wild caught. The Department has entered into a cooperative agreement with the USDA to conduct assigned retail audits for compliance with the COOL regulations.

The department feels that this task force is unnecessary for labeling of seafood is already being regulated.

Testimony on HCR 79 Requesting the Chairperson of the Board of Agriculture to Convene A Task Force on Fish Labeling

Chair Wooley, Chair Tsuji and members of the Committees, I am Brooks Takenaka, Assistant General Manager of the United Fishing Agency, Ltd. ("UFA"), located at Pier 38 since 2004. United Fishing Agency is also known as the "Honolulu Fish Auction" which auctions "wild caught" fish primarily by long line fishing vessels, private citizens & corporations holding Hawaii commercial fishing licenses.

I'd like to take this opportunity to offer comments for your consideration regarding the fish labeling issue with respect to the following:

• <u>Identity of Fish Species</u>: The proper identity of fish species is already regulated and enforced by the U.S. Food & Drug Administration ("FDA"). UFA identifies and labels each species sold through UFA.

• <u>Country of Origin</u>: The fishes "country of origin" is already covered by the U.S. Department of Agriculture ("USDA") and the industry is largely in compliance due to current enforcement as well as more significantly the continual demand for transparency and third party audit certification on "country of origin" labeling by large organizations such as Whole Foods, Costco, Wal-Mart and big restaurant chains that purchase from the vast majority of wholesale seafood distributors.

◆ <u>Wild or Farm Raised</u>: Again this is already covered and enforced by the FDA labeling laws and has been in force since the 2008 Farm Bill. Most of the pelagic (open ocean) and all of the benthe-pelagic (deep sea bottomfish) sold at UFA are wild & line caught. A limited amount of pelagic, long line caught species are frozen at sea. These species do not have extended shelf life as other species and this helps prevent discards.

The marketing system at UFA documents and provides the following information:

- Name of fishing vessel;
- Date of off loading & sale;
- All species are properly identified;
- Each purchaser is identified;
- All pertinent information regarding the fish sold are provided to buyers.

Requiring the purveyors to label all seafood relative to the parameters presented in HCR 79 will result in significant costs to the purveyors and ultimately to consumers.

In the "further resolved" clause, proper definitions will be required for "net caught", "open waters", "wild", and "Hawaiian".

Additional concerns are:

- Who will administer the program?
- Who will monitor and what methods will be applied to monitor?
- Who will enforce and how will it be enforced?
- What are the costs for this kind of labeling program?

Lastly, the resolution calls for UFA to have a seat on the task force and we humbly request to be **<u>excluded</u>** since we do not want to sit in judgment of the wholesalers and retailers with whom we have long standing business relationships.

Mahalo for allowing us to share our comments.

- Well-informed consumers can enhance fishery management processes with responsible market choices.
- Link responsible fishery management to responsible fish consumption.
- Free Trade and Globalization Effects favor imported seafood.
- Today, over 80% of seafood in the US is imported. Local competitiveness is down!
- But, foreign fisheries are less intensively regulated, with questionable seafood safety.
- Consumers need help distinguishing "costs" of domestic versus imported seafood.
- <u>COOL Rule</u> (Country of Origin Labeling)
 - New USDA requirement for labeling
 - Distinguishes wild vs. farmed fish
- Sustainable, local food production is important!
- Industry is important to Hawaii's diversified economy.
- Fresh Island fishery products are important to Hawaii's culture and heritage.
