Aloha Chair Hanohano, Vice-Chair Cullen, and Members of the Committee: The Department of Hawaiian Home Lands (DHHL) supports the general intent of this resolution that urges Hawaii's congressional delegation to provide DHHL with federal funding.

While DHHL is in need of funding for the development of homestead lots to be awarded to our beneficiaries, we currently receive approximately \$12 million per year in funds through the Native American Housing Assistance and Self-Determination Act (NAHASDA) that is administered by the U.S. Department of Housing and Urban Development (HUD). DHHL also receives support each year through other federal programs like loan guarantees and insured loans, as well as grants for water and waste water systems on Hawaiian home lands. We are ardently fighting to keep the federal resources we already have because there is great opposition to providing funds to native Hawaiian programs. While the intent of this resolution is good, securing additional federal funding for DHHL may not be feasible at this time.
