In consideration of HOUSE CONCURRENT RESOLUTION 38/HOUSE RESOLUTION 20 URGING THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES AND HAWAII TOURISM AUTHORITY TO CHOOSE A LOCATION FOR, BUILD, AND OPERATE AN INFORMATIONAL KIOSK FOR THE PUBLIC IN THE HISTORIC DISTRICT OF HONOLULU

House Concurrent Resolution 38/House Resolution 20 urges the Department of Accounting and General Services and the Hawaii Tourism Authority to choose a location for, build, and operate an informational kiosk for the public in the Historic District of Honolulu. The Department of Land and Natural Resources (Department) appreciates the intent to promote greater educational awareness of our historic sites in downtown Honolulu, but does not support these resolutions, as a kiosk would increase the clutter of the Capitol Historic District and downtown Honolulu.

The Department would suggest that in lieu of a kiosk, that an interactive map application (app) for smart phones and ipads be created (The cities of Spokane and New Orleans have free apps available at the Apple I-store or through Google Play for you to review the concept.). This would avoid the need to construct anything in the Capitol District, and would allow tourist and locals to look up sites before driving down to the Capitol, thus allowing them to better plan their day. Furthermore, updates to the app would be much easier to make than to a kiosk and there is no risk of vandalism. The Department believes that for the same cost as a kiosk the state can develop a much better product that is widely available and that can be easily branded. Finally, developing an app would be in keeping with the Governor's information technology transformation plan.

TESTIMONY OF THE STATE FOUNDATION ON CULTURE AND THE ARTS TO THE HOUSE COMMITTEE ON TOURISM ON MARCH 18, 2013

Chair Brower, Vice Chair Cachola, and members of the Committee, I am Eva Laird Smith, executive director of the State Foundation on Culture and the Arts. I am pleased to support House Concurrent Resolution 38 / House Resolution 20, provided passage of these resolutions do not replace or adversely impact priorities indicated in the Executive Budget.

The State Foundation on Culture and the Arts situated in the historic No.1 Capitol District Building just across the State Capitol, has been involved in encouraging the growth of cultural tourism since the decision was made to move our agency to its current location in the heart of the Capitol District. We opened the Hawai'i State Art Museum in 2002, a café and amenities a few years later, and our interest has always been to share Hawaii's history and culture with our residents and visitors through a visitor information program.

Today, our HiSAM volunteers staff the information desk on the ground floor of our building, providing information and a warm welcome to all visitors. An informational kiosk within the historic district would greatly facilitate recreational visits to the downtown area, and serve to highlight the various cultural differences along a cultural hub.

We are long overdue for attractive signage and directional displays of not only historic buildings and the State Capitol, but also the downtown business district where First Friday programs, restaurants, private art galleries, and retail shops continue to grow. Our agency stands ready to facilitate the development of an informational kiosk, with support from DAGS and the Hawaii Tourism Authority.
