Chair Takai and members of the Committee, I am Eva Laird Smith, executive director of the State Foundation on Culture and the Arts. I am pleased to support House Concurrent Resolution 116 / House Resolution 87, provided passage of these resolutions do not replace or adversely impact priorities indicated in the Executive Budget.

The State Foundation on Culture and the Arts opened the Hawai'i State Art Museum in 2002 to house and display the Art in Public Places Art Collection, which was created in the name of the people of Hawai'i. Our interest has always been to share Hawaii's history and culture with our residents and visitors through sharing the collection and providing educational programming for intergenerational audiences developed around the Collection.

Today, HiSAM exhibitions at any given time are free to the public and accessible to all visitors. We have hosted thousands of public and private school students in our brief history and have worked with many of them in our Art Bento Program, which provides hands-on art workshops in a variety of media. Every year the State Foundation hosts the Scholastic Art Exhibition at HiSAM, giving students a rare opportunity to enter an art competition and for their work to be seen in a quality venue. We also host Second Saturdays in the museum to encourage the art experience for children and their families.

Most assuredly, we can do more. We are currently renovating a space in the No. 1 Capitol District Building to provide a much more appropriate venue for children and young people to create art. In the coming months, we will be addressing a new strategic plan and will introduce new programs to be developed for the youth of Hawai'i.

Thank you for your continued support of our progress on behalf of educating the children and youth of Hawai'i and for the opportunity to testify on this matter.
