I write this letter in strong support of the Honorable Kevin Souza's nomination by Chief Justice Mark E. Recktenwald to serve as a Family Court judge.

I am the President of the State of Hawaii Organization of Police Officers ("SHOPO"), which is the public sector union that represents all of our county police officers serving throughout the 50th State.

As a police union, we pay close attention to the judiciary appointments since the end product of our investigations is often the decisive factor in a court proceeding. In addition, our officers spend significant amounts of time interacting with the judges and testifying in their courtrooms. Our review and evaluation of a nominee is based on several factors, including but not limited to intelligence, legal knowledge and experience, integrity, judicial temperament and diligence. We use our evaluations to determine whether we will support, oppose or remain neutral on a particular nominee. We take our evaluations and recommendations seriously, as we know that the position we take on a nominee could negatively impact a nomination.

As for the nomination of per diem Judge Souza to a full time position, we voice our unequivocal and strong support for a nominee who we believe is exceptionally qualified to serve on the Family Court bench. As the largest public law enforcement labor organization in Hawaii, we support and endorse Judge Souza's nomination to this most honorable and distinguished position.

Judge Souza comes to the bench with extensive litigation experience gained from his solo law practice and having served six (6) years with the Office of the Public Defender, in addition to having worked at the McCorriston Miho law firm. Aloha mai kākou. My name is Robert N.E. Piper and I thank you for the opportunity and honor to submit this testimony in strong support of Judiciary Communications No. 1 nominating Kevin A. Souza to the District Family Court of the First Circuit, State of Hawaii.

We don't often take the opportunity to thank our civic leaders for their dedication and leadership – so I will start off by extending my fond mahalo nui to you for your continued service to Hawaii.
