# MEASURE:S.B. No. 1042TITLE:Relating to the Public Utilities Commission

Chair Baker, Chair Hee, and Members of the Committees:

# **DESCRIPTION:**

This measure amends Section 269-3, Hawaii Revised Statutes ("HRS"), and Act 177, Session Laws of Hawaii 2007, ("Act 177") relating to staffing and recruitment by the Public Utilities Commission ("Commission").

# POSITION:

The Commission strongly supports S.B. No. 1042, as it is critical to the Commission's efforts to build its capacity to be proactive and effective in responding to its duties in a rapidly changing regulatory environment. The Commission offers the following comments for the Committees' consideration.

# COMMENTS:

This bill would provide the Commission with needed flexibility to recruit and hire staff with the right skill sets to effectively carryout the Commission's regulatory duties, particularly in the area of energy regulation. The 2007 Legislature passed Act 177 authorizing the reorganization of the Commission in response to the findings of a 2004 legislative audit and a subsequent study by the Hawaii Energy Policy Forum. The provisions of Act 177 mandate specific position descriptions for Commission staff based

on the Commission's needs during that period, which makes recruitment of personnel to satisfy the Commission's current regulatory needs very difficult. This bill would support the Commission's efforts to identify key positions and rewrite position descriptions to build up staffing required to carry out its many current and future duties by eliminating the restrictions of Act 177.

After being assigned additional space within the Kekuanaoa Building in July 2012, the Commission has continued to work on its office expansion and renovation plan with the assistance of the Department of Accounting and General Services, the Department of Budget and Finance, and the Office of the Attorney General. This assignment finally gives the Commission the space needed to house its additional staffing requirements. As the Commission's office expansion plan moves forward, S.B. No. 1042 will serve to support the Commission in designing and filling the kinds of positions needed to modernize and transform the agency to meet the needs of a rapidly changing regulatory environment.

Finally, the Commission has recently received guidance from the Department of Human Resources Developm ent on how to further amend the bill's proposed language to improve the flexibility of the Commission in its recruitment and staffing efforts. The Commission asks the Committees to consider amending certain language in the current measure [page 1, line 9 to page 3, line 2] to read as follows:

SECTION 2. Section 269-3, Hawaii Revised Statutes, is amended to read as follows:

"§269-3 Employment of assistants. (a) The chairperson of the public utilities commission may appoint and employ [clerks, stenographers, agents, engineers, accountants,] professional staff and other assistants for the public utilities commission as the chairperson finds necessary for the performance of the commission's functions and define their powers and

The chairperson may appoint and, at pleasure, duties. dismiss a chief administrator and [hearings officers] attorneys as may be necessary [-], and who shall be exempt from chapter 76. [Notwithstanding section 103D-209, -the-chairperson-shall appoint one or more attorneys independent of the attorney general who shall act as attorneys for the commission and define their powers and duties and fix their compensation. The chief administrator, chief-of policy and research, chief of administrative support, chief of consumer affairs --- and compliance, --- utility --- analysts, and attorneys shall be exempt from chapter 76. Research assistants, economists, legal secretaries, legal assistants, and enforcement officers may be appointed with or without regard to chapter 76. Other employees shall-be appointed as may be needed by the chairperson in accordance with chapter 76.] The chairperson may also appoint other staff with or without regard to chapter 76.

(b) Notwithstanding section 91-13, the commission may consult with its assistants appointed under authority of this section in any contested case

> or agency hearing concerning any issue of facts. Neither the commission nor any of its assistants shall in such proceeding consult with any other person or party except upon notice and an opportunity for all parties to participate, save to the extent required for the disposition of ex parte matters authorized by law."

Testimony of Sharon Y. Moriwaki, Co-Chair, Hawaii Energy Policy Forum

I am Sharon Moriwaki, Co-Chair of the Hawaii Energy Policy Forum (Forum). The Forum is comprised of 45 representatives from Hawaii's electric utilities, oil and natural gas suppliers, environmental and community groups, renewable energy industry, and federal, state and local government, including representatives from the neighbor islands. We have been meeting since 2002 and have adopted a common vision and mission, and a comprehensive "10 Point Action Plan," which serves as a framework and guide in meeting our preferred energy vision and goals.

SB 1042 proposes to update Section 269-3, HRS and Act 177 (2007), relating to the Public Utilities Commission (PUC) and its employment of assistants, which the Forum strongly supports as critical to enhance the effectiveness of the important work of the PUC.

One long-standing, unanimous priority of the Forum has been the revitalization the Public Utilities Commission (PUC) and the Division of Consumer Advocacy (DCA). The vitality of these important regulatory agencies is essential to ensure that the implementation of Hawaii's energy policies is effective, fair, cost-effective, and reasonable. In addition to regulating utility expenditures of over \$4 billion dollars annually, the PUC is tasked with developing and implementing many technically complex policy matters that affect every one of Hawaii's people on a day-to-day basis. Energy policy legislation and clean energy policies leave many of the most difficult, sensitive and technical determinations to the PUC for ultimate resolution and implementation. It was for this reason the Forum conducted a study in 2003, and urged the reform and reorganization of the PUC. The resulting Act 177 lay the foundation, with specific positions that were deemed to be needed at that time. Major strides in clean energy policy and programs have been made since Act 177. The result, while good for Hawaii's clean energy future, impacts significantly on the PUC. In order to do this effectively and make sound decisions for the best interests of our state, the PUC requires skilled and competent staff in a rapidly changing field. We cannot overemphasize the importance of allowing the PUC to develop a staff capability that is sufficiently qualified and can, over the long term, develop the extensive institutional experience necessary to develop, implement, and maintain progressive energy policies. The PUC faces exceptional challenges in recruiting and maintaining the specialized staff needed to provide the unique nexus of technical, economic, policy, and legal expertise necessary for enlightened energy regulation. SB1042 would remove obstacles and would facilitate the efficient and effective recruitment and retention of the qualified staff well suited to the PUC's important duties.

Based on the foregoing, the Forum strongly supports SB1042 and respectfully urges passage of the bill. Thank you for the opportunity to testify.
