The City and County of Honolulu's Department of Environmental Services (ENV) supports Senate Bill 1304, Proposed SD1, Relating to Economic Development, which would authorize the issuance of State of Hawaii general obligation bonds in the sum of \$500,000,000 and appropriate the funds to the City and County of Honolulu for sewer infrastructure improvements. Such funds would allow the City and County of Honolulu to add capacity upgrades not within Consent Decree requirements without adding to rate payer burden. Capacity upgrades would support urban infill with benefits to transit use and community improvements.

The City and County of Honolulu has approximately 2,100 miles of sewer lines that range in age from new to over 80 years old. It is constantly necessary to upgrade these sewer lines to both ensure effective safe operation, improve reliability, and to provide necessary capacity for the community. As you know, the City and County of Honolulu entered into a Consent Decree with the U.S. Environmental Protection Agency and the State of Hawaii in 2010. That Consent Decree, which incorporated ongoing work from a 1995 Consent Decree and other documents, focuses requirements through 2020 on improvements to the wastewater collection system to improve reliability and to The Honorable Donovan Dela Cruz, Chair The Honorable Will Espero, Chair February 12, 2013 Page 2

reduce spills. Improvements to the existing collection system include rehabilitation or replacement of lines with structural problems and capacity upgrade of those lines where existing capacity limitations have or may cause spills. While we do add capacity where required to specific projects called for in the Consent Decree, this does not address all system capacity requirements.

The City and County's Capital Improvement Program for the wastewater system for the period 2001 to 2020 anticipates total appropriations of \$4.915B and expenditures over the same period of \$4.312B. This is all rate payer supported. As additional capacity needs are identified in support of development plans, significant additional work and cost could be required to upgrade the capacity of sewer lines within developed areas all adding to rate payer burden. Any opportunity to support capacity upgrades and provide timely opportunity for development without adding to rate payer burden would be welcomed.

Aloha Chairs Dela Cruz and Espero, Vice Chairs Slom and Baker, and Members of the Committee:

The Pacific Resource Partnership (PRP) is a labor-management consortium representing over 240 signatory contractors and the Hawaii Regional Council of Carpenters.

PRP supports SB 1304, Proposed SD1 Relating to Economic Development. This bill authorizes the director of finance to issue general obligation bonds in the sum of \$500,000,000 or so much thereof as may be necessary and the same sum or so much thereof as may be necessary is appropriated for fiscal year 2013-2014 to the city and county of Honolulu for sewer infrastructure improvements.

Much of the state's past and projected population growth has and will continue to be focused on Oahu. Past land use and transportation patterns that have accompanied this growth have led to harmful suburban sprawl. This is one of the greatest environmental and economic threats to Hawaii.

within the urban corridor and in the designated growth areas, like Kapolei. This will require adequate infrastructure.
