Chair Green, Vice Chair Baker, and Members of the Committee:

The Honolulu Police Department opposes Senate Bill No. 1337, Relating to Health Wellness Programs.

Hawaii's current gambling laws have been touted as some of the strongest in the nation. This is because the current statutes and related definitions are practical, clearly written, and allow for specific activities. These activities include bona fide business transactions as well as health and accident insurance. These allowances make the need for amendments regarding health insurance unnecessary.

Furthermore, the bill does not define "wellness program" and does not specify what activities would be involved. As long as lotteries or other contests of chance are not used in the promotion or application of the program, no changes to the current statutes or definitions are required.

The Honolulu Police Department urges you to oppose Senate Bill No. 1337, Relating to Health Wellness Programs.

Re: Senate Bill 1337 Relating to Health Wellness Programs

Dear Senator Green:

The Hawai'i Police Department opposes passage of Senate Bill 1337, relating to Health Wellness Programs. The intent of the appropriation is to amend the definition of "something of value" to clarify that participation in health wellness programs is not considered gambling or lottery participation under the Hawai'i Penal Code.

Our Department is opposed to this measure as currently written. Our concern is predicated upon the passage, "Payment for health insurance coverage **or** (emphasis mine) participation in a wellness program...", which could provide a source of ambiguity. We believe failure of this legislation to adequately define a wellness program could allow for a moderately liberal interpretation to apply this statute towards legalization of certain acts of gambling.

For instance, one could construe that a game of poker designed to promote dexterity to stave off arthritis could, in effect, allow the person in control of the property whereat the poker game is occurring to directly benefit from such gambling activity.

For these reasons, we oppose this legislation. Thank you for allowing the Hawai`i Police Department to provide comments relating to Senate Bill 1337.
