Aloha,

On behalf of the Dr. Martin Luther King, Jr. Coalition-Hawaii, I write in SUPPORT of bills SB 1359 & HB1433.

"The month of October shall be known and designated as "Non-violence and Peace Awareness Month", to Promote Public awareness of violence as a significant social, Public Health, and criminal justice problem."

While we support the intention of the bills; we find that they are negative in language and shortsighted in scope. The word **PEACE** is not mentioned in the body of the bill. The definition of **non-violence** is positive. And public awareness should be taught and demonstrated at every level. If we are going to designate the month of October to non-violence awareness, the root of non-violence should be the focus of the bill.

The month of October was selected by the United Nations because it is the birthday of Mahatma Gandhi. The Gandhian ahimsa is a philosophy and strategy for social change that rejects the use of violence, but at the same time sees nonviolent action (also called civil resistance) as an alternative to passive acceptance of oppression.

Dr. Martin Luther King Jr. and the modern-day Civil Rights Movement's use of non-violence was not passive. Nonviolent acts of protest and persuasion are symbolic actions performed by a group of people to show their support or disapproval of something. The goal of this kind of action is to bring public awareness to an issue, persuade or influence a particular group of people, or to facilitate future nonviolent action.

Yes, violence is a "significant social, Public Health, and criminal justice problem", however unless we are taught how to use non-violence as a way of life, then we have missed a golden opportunity.

We would like the bill to be amended so that it better represents the title of the bill –"Nonviolence and Peace".

Dear Senator Chun Oakland, Senator Galateria, and Members of the Committees,

Aloha mai kakou.

The Inclusive Orthodox Church supports Senate Bill 1359. The recognition of a month of non-violence and peace awareness is fully consonant with the Christian teachings of our church.

We believe that it is a Christian's active duty to seek and work for social justice. This is the Way that Jesus admonished his followets to follow. In fact, actions of social justice are the only basis on which peace may be achieved within our community. Social justice is best achieved through non-violent means. We espouse life, liberty, and justice for all, which – unfortunately – rarely occurs in our society. That is why establishing a month focused on non-violence and peace is so essential.

No one embodies this principle more than Mohandas K. Gandhi, the Mahatma. We recommend that the month of October be dedicated to non-violence and peace awareness and, by way of amendment, that October second be recognized as Mahatma Gandhi's Birthday. There is long-standing tradition that, on the Mahatma's birthday, the Gandhi International Institute for Peace and Indian-American Priendship Council holds a peace ceremony at the statue of Mahatma Gandhi at Kap'lolarit Park. This event can continue to be the cornerstone around which efforts at bringing awareness to how non-violent change is the only way to peace are brought to the current and future generations.
