Subject: Senate Bill No. 192, Relating to Prostitution

I am Jerry Inouye, Captain of the Narcotics/Vice Division of the Honolulu Police Department, City and County of Honolulu.

The Honolulu Police Department supports Senate Bill No. 192, Relating to Prostitution.

Since children are vulnerable and deserve additional protection, it is reasonable to strengthen statutes and penalties for crimes that exploit our youth. We also recognize that the victims of such cases experience intense physical and mental trauma. Extending the statute of limitations from two to six years would allow them greater time to get assistance without relinquishing their right to seek justice.

The additional changes amending the State's forfeiture and sexual offender registry laws would ensure that the registry remains consistent with current statutes. This sends a strong message to individuals willing to engage in prostitution activity.

We urge you to support Senate Bill No. 192, Relating to Prostitution.

RE: Testimony IN SUPPORT of SB192

Makes solicitation of a minor for prostitution a crime. Increases the statute of limitations to bring a cause of action for coercion into prostitution from two to six years. Clarifies the minimum and maximum fine for a person convicted of committing the offense of prostitution. Adds the offenses of solicitation of a minor for prostitution, habitual solicitation of prostitution near schools and public parks under the State's forfeiture laws. Amends the definition of "sexual offense" under the sexual offender registry laws to include acts that consist of the solicitation of a minor who is less than eighteen years of age for prostitution.

Dear Committee and Judiciary and Labor:

I, Brittani M. Williams am a Master of Social Work student at the University of Hawai'i at Manoa who is strongly in support of SB192. Currently, penalties regarding prostitution are considered a misdemeanor in the State of Hawai'i. Increasing penalties for customers who engage in prostitution or sex trafficking with minors is a necessary step toward holding criminals accountable for inhumane crimes. It is my obligation to speak on behalf of those who cannot speak for themselves due to societal circumstances, fear of their lives, and community predispositions.

Prostitution is a controversial problem that involves complex interests, values, and issues in the community at large. Individuals involved in prostitution and or are sex trafficked are often times the ones being criminalized while their pimps identity go unknown. It is important to note that victims of underage prostitution are put into circumstances where they live in fear of their lives. Also, those who engage in selling individuals for sex, control almost every part of their victim's life. Victims are not free to leave and they are not making any money.

A story featured in the Hawaii Reporter describes a 16 year old local high school student who was kidnapped and forced by a pimp to work on the streets of Chinatown and Waikiki as a prostitute. She described the humiliating experience and the fear of leaving her pimp since he threatened to kill her and her family. This is just one of many stories of minors who are victimized by these violent individuals.

Criminalizing an individual for purchasing a person for sex has the potential to not only reduce recidivism rates but also violence toward prostituted or trafficked persons, especially minors. In Hawai'i, there are no known severe penalties for patrons of prostitution and sex trafficking. Patrons need to be held accountable to the public. Awareness is key, the community needs to know of the pervasiveness of this problem and criminals should fear real consequences for selling humans for financial gain. These individuals have real problems and dismissing their actions by giving them a misdemeanor does no justice. They should be required to attend a treatment or counseling program for a longer period of time to effectively treat their violent and deviant behavioral disorders.

It is time to help end the fight against modern day slavery.

As a student of Social Work at Hawaii Pacific University and a resident of Oahu Senate District 10, I submit this testimony in support of SB192.

Shared Hope International has conducted a study evaluating states on legislation that must exist to, "effectively respond to the crime of domestic minor sex trafficking."¹ Hawaii received the grade of "**F**" and the report stated, "Hawaii has not enacted a sex trafficking law and lacks laws to penalize and deter buyers from purchasing sex acts with minors."²

The Pacific Alliance to Stop Slavery (PASS) is a Hawaii based not-for-profit that works directly with survivors of Human-Trafficking. As an organization that works with victims fist hand, I trust and support their advocacy for this bill.

All of these individuals without exception would be considered by those in society without a clear understanding of domestic human trafficking, as prostitutes. It can be confusing to identify as victims girls that present themselves in a brazen and willing manner to prostitution. To one without understanding they would seem complicit. However, when one spends quality time with and builds trust with these girls the honest answers will reveal that these girls have been in the simplest and gentlest of terms "tricked," duped into believing that this was their lot in life. That a life of servicing men sexually was all that they were going to be successful at. And in the most brutal of terms and equally honest they are "tortured." Attacked from every angle by sex traffickers aka "pimps." They are Physically beaten, threatened, emotionally, and psychologically tormented and ultimately manipulated into bringing in cash for these "evil ruthless businessman." We are talking about young girls suffering unthinkable trauma and further victimized by a culture and society that holds them as responsible coconspirators with their predators. Without question or need for discussion adults that profit from or enable a child under 18 years of age to engage in sexual acts, are sex predators and should be judicially addressed as such. The fact that a business enterprise was in the works does in now way negate the perversion. Society must begin to help these children heal by at the very least defining their trauma as an illegal act. Comments: I support this bill particularly as it relates to an increase in statute of limitations to bring a cause of action for coercion into prostitution. Although there are also male victims of prostitution, for simplicity I will use pronouns referring only to females. Both mental, emotional and physical restraints can retard a victim's ability to report her experience. Mentally, we have an innate "power" to block the memory of traumatic events. Emotionally, the victim is dealing with issues of (false) guilt and shame, as well as fear for the people who have been threatened if she attempts to escape or report the coercion. In some cases, the victim will come to believe that her pimp actually loves her, and she loves him. Until she can understand that she has been used and abused, she may not be willing to report her pimp. Physically, once the victim has been rescued or has escaped her pimp, she remains under the threat of retaliation where she may be brought back under her pimp's control, sold to another pimp, beaten, killed, or all of the above. She needs to be able to hide in a protective place until it appears safe to pursue a "normal" life. The process of achieving (abstracted) normality can easily take years. Please be a part of the solution by passing this bill.
