Testimony of the Office of the Public Defender State of Hawaii to the Senate Committee on Judiciary and Labor

February 15, 2013

S.B. NO. 194 **RELATING TO CRIMINAL PROCEDURE.**

Senator Hee and Members of the Committee:

S.B. 194 would expand the list of offenses for which a deferred plea would not be possible. We are concerned with the proposed exclusion of first time offenders who solicit prostitutes, convicted under HRS Sections 712-1200 (1) (b) and 712-1207(1)(b).

It is regrettable that there are still persons who offer sexual relations for a fee and persons who offer to pay a fee for sex. But this does still happen in our society and this activity is even given a veneer of acceptability in modern culture through films such as "Pretty Woman", for example.

We don't believe that a first-time offender should be denied the possibility of a deferred plea. Unlike many other states, Hawaii does not allow for expungement of a criminal conviction. In light of that, the possibility of a deferral becomes even more significant. We believe that the court should have discretion to decide those cases where a deferral would be appropriate.

We propose amending this bill by adding the words "a second conviction for" to subsections (W) and (X). Without that change, we cannot support this legislation.
