My name is Matthew Bishop, Chair of the Board of Nursing ("Board"). I appreciate the opportunity to testify on Senate Bill No. 198, Relating to Advanced Practice Registered Nurses. I apologize for the lateness of the filing of the Board's testimony; however, the Board did not review the contents of this bill until its meeting on February 7, 2013.

The Board supports the bill with amendments. This bill would amend HRS 457-8.5(a) by recognizing the National Council of State Boards of Nursing's ("NCSBN") advanced practice registered nurse ("APRN") Consensus Model ("Model") and clarify the language relating to APRN educational requirements to be consistent with that of the Model.

The Board determined that the language to recognize the Model in its entirety, proposed on page 3, lines 18 – 21, was too broad. The Board understands the purpose of adopting such a Model, as each state independently decides the APRN scope of practice, roles and titles, and requirements for

licensure, including national certification and the Model would provide uniformity among all the states. However, the Board determined that its current requirements include the specific sections of the Model that they deemed applicable for the licensure and practice of an APRN and, therefore this amendment was not necessary.

The Board does support the amendment on page 3, line 17, to delete the effective date of October 1, 2009, and also supports the amendment on page 4, lines 13-15, that would clarify the education requirement for APRN licensure, consistent with the Model.
