Currently nurses can only be recognized as APRNs if they have a Master's degree in nursing. This precludes nurses who earn their Doctor of Nursing Practice (DNP) and other nationally recognized clinical doctorates in nursing. This directly impacts DNP graduates of the UHManoa School of Nursing and Dental Hygiene and the UH Hilo School of Nursing. The DNP degree includes all of the requisites of the Master's degree for advanced practice nurses. In addition, according to the Institute of Medicine, the APRN prepared in a DNP program has competencies in : 1) scientific research of practice, 2) organization and system leadership and management, quality improvement and systems thinking, 3) utilization of information technology and information for the transformation of healthcare, 4) health policy development, and 5) interdisciplinary collaboration for improving patient and population

outcomes. These competencies are necessary for the emerging healthcare models which focus on interdisciplinary and collaborative patient centered and patient engaged healthcare. The Master's degree requirement impedes other states' APRNs with clinical doctorates in nursing degrees. Amending Section 457-8.5(a)(4) will put Hawai'i in sync with the rest of the Nation and the National Council of State Boards of Nursing APRN Consensus Model.

At this time of primary provider shortage, it is important to allow Advanced Practice Nurses to provide patient care to individuals and communities to the fullest extent of their education and training. Aloha my name is Denise Cohen PhDc, APRN, FNP-BC, although I'm a member of the Board of Nursing I am also a practicing APRN, and a nurse educator. I appreciate the opportunity to testify in support for Senate Bill No. 198, relating to Advanced Practice Registered Nurses, that would amend HRS 457-8.5(a) by recognizing the National Council of State Boards of Nursing's ("NCSBN") advanced practice registered nurse ("APRN") Consensus Model and clarify the language relating to APRN educational requirements consistent with that of the APRN Consensus Model.

As health care becomes more complex the educational requirements for APRN's to obtain board certification are increasing along with other healthcare professionals such as physicians, pharmacists and physical therapists. Currently nurses can only be recognized as APRNs if they have a Master's degree in nursing. This does not allow those who earn a Doctorate in Nursing Practice (DNP) and other nationally recognized clinical doctorates in nursing. This directly impacts DNP graduates from the UHM SONDH Manoa and UH Hilo School of Nursing. Both programs offer doctorates in nursing the nursing degrees without necessarily having a Master's in nursing. In addition, the
