In consideration of SENATE BILL 215, PROPOSED SENATE DRAFT 1 RELATING TO ECONOMIC DEVELOPMENT

Senate Bill 707, Proposed Senate Draft 1, proposes to: (1) establish the Public-Private Partnership Authority ("Authority"); (2) require the Authority to initiate a pilot project; and (3) appropriate an unspecified sum for the Authority. **The Department of Land and Natural Resources ("Department") supports the intent of this measure and offers the following amendments:**

- 1. Public-Private partnerships can enhance economic and conservation activities for the Department. We ask that clarifying language be included, as needed, to ensure that non-profit entities are eligible to engage in the projects described under the scope of this bill;
- 2. State Parks are currently excluded under this bill. The Department urges the inclusion of State Parks so we can utilize the beneficial assistance of the Authority to maintain and enhance these vital recreational public assets that will be attractive and inviting to visitors and residents alike; and
- 3. The Department is concerned about the potential alienation of lands from our public land trust. As such we recommend striking the reference to purchase options on page 6, line 19 in Part I, Section -4, Item 9 to read as follows:

[Grant options to purchase any project or to] To renew any lease entered into by the authority in connection with any of its projects, on the terms and conditions it deems advisable.

Subject: Senate Bill No. 215, Proposed SD 1 Relating to Economic Development

The Department of Planning and Permitting **supports** Senate Bill No. 215, Proposed SD 1, which would establish a Private-Public Partnership Authority (P3A), to plan, implement and manage projects.

We support the redevelopment of underutilized lands, especially in our transit corridor. We need to make better use of urban lands by emphasizing compact, mixed use development. This leads to healthier lifestyles, reduced infrastructure maintenance and less dependence on the private car. This bill could play a significant role in meeting these objectives. The proposed pilot project of building a new film studio in Kapolei could be consistent with these City policies, if built within the transit corridor.

We are not taking a position on whether the P3A is the best vehicle to achieve the goal of making better use of State lands. However, designating an existing agency could be a viable option that reduces administrative costs. In addition, it may be useful to have a legislative intent section so that its mission is more focused and its relationship with the Hawaii Community Development Authority (which is also a redevelopment agency), is clarified.

We understand that P3A is not intended to infringe on county homerule, and it will comply with county plans, zoning and development codes.

Thank you for this opportunity to offer testimony on **Senate Bill 215** (Proposed SD1) relating to economic development. We understand that the State is facing fiscal challenges while continuously having to address the ever increasing infrastructure and service needs. We also understand that the original purpose of this measure was to create a vehicle and process for public-private partnerships to work collaboratively with state agencies and other public and private entities to help generate funds from state lands to bolster the revenue-strapped departments and agencies that operate throughout the state. Such funds can be used to better manage, service, and make needed capital improvements to our facilities.

As Mayor of Maui County, I can **SUPPORT** SB 215, **but contingent** upon the following:

- 1. That the law relating to the Public Land Development Corporation be repealed;
- 2. That this bill receive full and transparent review, public input, and meaningful discussion through the state's normal legislative processes;
- 3. That the State NOT be able to exempt projects under this measure from statutes, ordinances, charter provisions, and rules of any government agency relating to special improvement district assessments or requirements; land use, zoning, and construction standards for subdivisions, development, and improvement of land; and the construction, improvement and sale of homes thereon unless coordinated with the counties via an collaborative agreement (i.e. memorandum of agreement or understanding).

4. That the legislature acknowledges that each of the counties and their communities are unique, and that it is vital that the counties' right to "home rule" is preserved by allowing the counties to retain their ability to review and approve or disapprove of projects proposed for development within the individual counties. Specifically, my administration requests that the following language be added to Section 5, at subsection (e):

"The counties may, by ordinance, waive zoning, land use, and permitting requirements on any project; provided that the authority shall enter into a development agreement with the county prior to project construction."

And,

5. That the scope of the measure is narrowed to allow for "pilot projects". As Mayor of Maui County, I respectfully request that the County of Maui be added as a "pilot project" with the following language added to Part II, Section 2:

"SECTION 2. After the adoption of rules pursuant to section _____-4(a) (4), Hawaii Revised Statutes, the public-private partnership authority shall initiate a pilot project pursuant to chapter ______, Hawaii Revised Statutes, for the development of a film production facility on state lands in Kapolei, and a main-street project on state lands in Wahiawa, city and county (sic) of Honolulu, and similar projects for educational purposes and to stimulate economic development and job creation in all counties."

Public-private partnerships can significantly boost government's ability to provide essential public services as well as keep pace with the increasing demand for the construction and maintenance of public facilities. This proposed legislation appears to have the potential to create such benefits for the residents of our state.

The proposed SD1 is worthy of further discussion. I would hope that the measure moves forward with the full benefit of public input. Expecting that more changes will occur, I would like to see a provision that specifies that any state exemptions from county statutes, charter provisions or any other county rule would only occur as a result of cooperative agreements such as memorandums of understanding, which on Oahu would be subject to review and approval by the Honolulu City Council.

I believe a successful project in Wahiawa could open the doors to other such projects, especially in rural towns that are fighting to retain their identity while remaining economically viable.

My name is Shannon Wood, the president and co-founder of the *Windward Ahupua*'a *Alliance*, a <u>501c3</u> Hawai'i non-profit corporation, which was established in July, 2002, to create the <u>Ko'olau Greenbelt & Heritage Trails System</u> in order to restore, protect & provide public access to the *mauka* lands on the Windward side of O'ahu along the base of *Na Ko'olau* as well as to support locally-owned sustainable economic activities in the more developed areas. Its mandate, however, has expanded over the past ten years well beyond these important regional issues.

WAA now works to educate & inform residents, visitors, businesses, policymakers at all levels of government, and the media about using **SMART GROWTH** principles which promote sustainability through urban (re)development to protect agricultural and conservation lands

Both personally and professionally, I thank you for replacing the original contents of this bill which would have created tax credits as an incentive for companies to expand or locate their operations in Hawai'i. It's not that I disagree with the concept; however, I support keeping the **Stadium Facilities Special Fund** alive since the **Public Land Development Corporation** to which it was administrative attached in <u>Act 282 - 2012</u> is in the process of being repealed.

The fund concept was initiated by a small group of *University of Hawai`i* football fans back in the fall of 2009 when the *NCAA* Division 1-A conference realignment talks began to heat up. We looked inside and out of the *Stadium* itself and decided that it would need at least \$250 million in capital improvements funding over the next 15 years in order to help *UH* be able to stay in the play. Remember, football revenues underwrite 20 other intercollegiate sports.

Rather than coming down to the *Capitol* every year shaking a tin cup for funding while competing for other **CIP** projects by other state departments & agencies, instead we decided that by (re)developing a portion of the 115 acres of parking lots right in the center of urban O`ahu, significant capital improvements can be funded from private sector resources who would be building

We see this as an attempt to put lip stick on the Public Land Development Corporation. When will you listen to the people across this state? We have been clear. by any name the Public Land Development Corporation and its exploitation of public lands for private and political purposes is repulsive to us. Whether re-named as a Public Private Partnership Corporation (PPPC) or a Public Private Partnership Authority (PPPA). It's the foundation these entities are built on that we oppose. SD1 would establish six (6) PPPA voting board members, with a majority of only four (4) necessary to make decisions on the taking of public lands statewide. So few people taking such significant liberties on public land is unacceptable to us. We believe it is contrary to the public interest. SD1 would enable the PPPA, like the PLDC, to manage, control and develop any public lands (state or county) transferred from any agency for unlimited purposes; including, for example, our "state parks" treasured by residents and visitors alike, developed for the purpose of "energy generation" (e.g., large natural resource acreage restricted from public use and enjoyment for conversion to wind farms with 400-foot wind turbines obstructing scenic view planes). We see this type of legislation as a problem. We are paying attention this time. SD1 would includes public school lands redevelopment and Aloha Stadium lands and facilities development, and their special funds. If these concepts have sound and significant public merit they should be considered and deliberated upon separately and in accordance with the full legislative process. SD1 would include a mysterious pilot project and report to be completed prior to additional development projects identified by the proposed PPPA as "suitable." There is no clarification of the type or scope of such pilot project in this open-ended measure, nor is there any definition of "suitable." Would this be "suitable" in terms of developers' needs and profits, or in accordance with the larger public's interest, needs and desires for present and future generations? While this measure selects several statutes for compliance purposes, it curiously overlooks HRS 205 and HRS 205-A (Land Use Commission, agricultural lands and coastal zone management) protections, among others. Thus this discriminatory tactic carries the appearance of avoiding regulations established in the public interest. Puna Pono Alliance stands in solidarity with the groups across this state in opposition to this legislation. We view SB 215 SD1 as another attempt to exploit protected public land for private purposes, we view this as an assault on our future and our way of life. RE: Strong opposition to SB 215 SD1-relating to Economic Development

The Outdoor Circle opposes this legislation.

The proposed Public Private Partnership Corporation (PPPC) and the proposed Public Private Partnership Authority (PPPA) are designed to exploit public land for the benefit of private developers. They are modestly refined versions of the Public Land Development Corporation (PLDC) which has been one of the most polarizing and universally opposed pieces of legislation in recent years.

The PPPA would consist of six members with only four members constituting a majority vote that would decide the future of whatever parcels of public land that the PPPC has in its sights. Giving four people this kind of power is unconscionable, regardless of their intentions. The lands targeted for development would include park land, conservation land, preservation land and other land classifications that generally describe open space that is highly valued by the public.

The Outdoor Circle has a standing Land Use Policy that strictly opposes using these types of lands for other purposes. This policy reflects the view of thousands of Outdoor Circle members, statewide, and in our opinion, much of Hawaii's general public.

SB215 SD1 fails to acknowledge and be guided by the lessons of the miserably failed (PLDC) by once again. Chapter 11 lists the HRS statutes to which all PPPC project would be required to comply but does not list the Land USe Commission, any entity related to agriculture lands, coastal zone management and others.

SB215 SD1 also fails to address the issues relating to home rule including whether the counties want the PPPC projects within their boundaries and the application of county zoning laws.

In short, while it is a bit scaled back from the monstrosity PLDC, the PPPC/PPPA are nothing more than another attempt to bring development to Hawaii's best land without proper oversight.

PROPOSED SD1 RELATING TO ECONOMIC DEVELOPMENT Testimony in OPPOSITION by Wayne Takamine The proposed SD1 for Senate Bill 215 and the proposed Public Private Partnership Corporation (PPPC) is very similar to the controversial Public Land Development Corporation (PLDC) that has created a storm surge of public disapproval. The proposed SD 1 includes areas of concerns that the public has voiced its opposition. Like the PLDC the PPPC has a limited amount of representation from the public at the community level. The proposed SD1 establishes six (6) PPPA voting board members, with a majority of only four (4) necessary to make decisions on the taking of public lands statewide. So few people taking such significant liberties on public land is undemocratic and contrary to the public interest. The proposed SD1 enables the PPPA, like the PLDC, to manage, control and develop any public lands (state or county) transferred from any agency for unlimited purposes; including, for example, our "state parks" treasured by residents and visitors alike developed for inappropriate commercial use. The proposed SD 1 does not show support for coastal zone management laws and it overlooks HRS 205 and HRS 205-A (Land Use Commission, agricultural lands and coastal zone management) protections, among others. From my conversations with stakeholders in the Kaka'ako Makai and Kewalo Basin Harbor areas that include numerous community groups and individual recreational park users, the proposed SD 1 is very similar to the PLDC and does not include adequate protection for the appropriate development of our valuable and sensitive coastal zone areas.
