Comments: I support the intent of this bill but have the following comments: We are currently 85-90% dependent on food from outside the state. This bill does nothing to encourage, support or improve food security but has every opportunity to do so. Selecting the highest bidders and backup lessees does not mean that the intended agricultural uses or crops will be for local food consumption. If the state and the DOA wish to get serious about the imbalance of our food economy, then the selection process should be one that places production of food crops intended for local markets on equal footing with highest bid, at the top of the selection process, and export crops at the bottom. Secondly, the DOA could take measureable steps at the lease-making process to reduce soil erosion and pesticide impacts by moving those applicants with best management practices in their farm plans or already in use on their current farms, to a higher position in the bid process. Highest bid means nothing if the impacts to the environment caused by poor farm practices (ie. soil and pesticide runoff or drift) costs the state much more in damage to its reefs, farm lands (soil loss and decline in soil quality), and neighboring communities. It is clear from satellite images of our coastal waters that existing BMPs are insufficient to prevent such damage. If we are going to make it easier for the DOA to get leases to new growers, I encourage the legislature to also make it easier for state ag lands to take a strong turn towards sustainability and food security.
