Aloha Chairs Galuteria, Wakai and members of the committees, thank you for opportunity to provide testimony in support on SB 235 which will adds the Daughters of Hawai'i as a member; change the representation of the appointed, non-organization representatives on the King Kamehameha Celebration Commission (Commission) from residents of the islands of Kauai, Maui, Molokai, and Hawaii to residents of the counties of Kauai, Maui, and Hawai'i; authorizes the Commission to appoint an executive director; and requires the executive director and clerk typist's salaries to be provided, in part, by the State. At its regular public in January 2013, the Commission approved the support of this measure and authorized its arts and programs to represent the Commission on this matter.

SB 235 is a simple step as the Commission re-invents and re-structures itself to become more effective and grounded. The commission is also looking internally to firm up it organizational policies, processes and procedures to fulfill its fiduciary responsibilities.

Background on the King Kamehameha Celebration Commission.

By Royal Proclamation on December 22, 1871 issues by Kamehameha V, June 11 was designated a public holiday to honor the memory of his grandfather Kamehameha the Great. He was and still is Hawai'i's greatest hero, warrior and statesman. He is honored each year by the citizens of Hawai'i with parades, pageantry, sports, hula, dignity and respect, a legacy to a great man, to his life and to his accomplishments.

In 1939, the Territorial Legislature established the Kamehameha Day Celebration Commission, which was to be responsible for the planning and managing of all the festivities. In 1974, the name was changed to the King Kamehameha Celebration, but the goals and purposes of the Commission have not changed.

Today, the Commission is made up of 13 commissioners representing several traditional Hawaiian organizations, as well as representatives from each of the neighbor islands. All commissioners are appointed by the Governor of Hawai'i for a limited terms and serve gratis

HRS §8-5 King Kamehameha celebration commission. (a) There shall be a commission to be known as the King Kamehameha celebration commission... e) The commission shall have charge of all arrangements for the celebration each year generally observed throughout Hawai'i

Nei on June 11, to commemorate the memory of the great Polynesian Hawaiian warrior and statesman King Kamehameha I, who united the Hawaiian Islands into the Kingdom of Hawai'i.

Historical Celebrations

The first "commemoration" was held on June 11, 1872 and was a day filled with sporting events held on the open plains of Kulaokahua, southeast of Honolulu, the highlight of which were horse races. The grand prize of the Kamehameha plate made in San Francisco for \$200.00 was won by a horse named "Carry the News to Mary."

In 1875, Kamehameha Day was celebrated with a three-hour long baseball game. A sham battle between the Hawaiian infantry and the cavalry highlighted the celebration in 1876.

In 1877, the celebration returned to horse races and the year that Kapi'olani Park was formally dedicated and the grand race program was produced. These horse races continued until 1911, when the legislature tore down the walls of the Jockey Club.

The first parade held as of the celebration was staged on June 12, 1916 and featured pa'u riders, civic organizations and the Honolulu Fire Department.

Current Activities

The Commission coordinates state-wide activities. On O'ahu, the Kamehameha statue lei draping ceremony is normally held on the Friday preceding the O'ahu parade and kicks off O'ahu celebrations events. On Hawai'i island, in Hawi, Kohala, the Kamehameha statue lei draping ceremony, parade and ho'olaule'a is always held on June 11. Hilo celebrates its lei draping at the Kamehameha statute at bay front on June 10th, and a ho'olaule'a is held at Mokuola. In Kailua-Kona, a parade through downtown Kailua along Ali'i Drive and a ho'olaule'a is held on the Saturday following the Kamehameha holiday. Both Kaua'i and Maui holds their respective celebration events on the Saturday following the Kamehameha Day holiday. Kaua'i parades runs from Vidinha Stadium to the County Building on Rice Street where a ho'olaule'a is held. Maui's festivities take place in Lahaina where the parade travels down Front Street and culminates in a ho'olaule'a at Kamehameha 'Iki Park.

I hope our testimony provide some context regarding the Commission. Again, thank you for opportunity to provide testimony in support of this measure.

SB 235 – Relating to the King Kamehameha Celebration Commission

Chairs Galuteria, Wakai and Members of the Committees:

My name is Elmer Ka'ai, Māmo Hawai'i, the designated representative to the King Kamehameha Celebration Commission (commission) for the Royal Order of Kamehameha 'Ekahi and the Commission's Chairperson. Thank you for the opportunity to provide testimony in strong support for SB 235, which provides the commission with essential processes and policies to improve its mission to commemorate the memory of the great Polynesian Hawaiian warrior and statesman King Kamehameha I. This measure is one of many steps to improve the commission.

The first change is to add a representative from the Daughters of Hawai'i. The Daughters of Hawai'i tradition is well documents and will be welcome addition on the commission. From my point of view, the great asset they bring to commission is their business and philanthropy expertise. They also bring a wealth of experience in non-profit arena. The removal of a Moloka'i representative is not a lost to the island; they will be well represented by the Maui (county) representative.

The second change impacts our current Arts and Program Specialist. The commission is seeking to provide this individual with a leadership role for the commission more in line with the roles and responsibility of an Executive Director. Currently, the members on the commission take on additional responsibilities besides its regular fiduciary duties as event planners and coordinators for most, if not all, of the state-wide celebration activities. My personal opinion is that the event planning and coordinators are not the roles of the commission; however, I believe this is how the commission was originally formed. Again from my point of view, the commission needs to refocus on its basic fiduciary responsibility and empower our executive director to manage and administer the task set forth by the commission.

The final change to this measure is the most critical – providing a steady funding source for the commission staff positions. In the mid-1990, former Governor Cayetano eliminated the budget

for the commission's staff positions; however, kept the commission administratively attached to the Department of Accounting and General Services (DAGS). The uniqueness of the commission is its ability to receive funds to pay for these positions and celebration activities from the collections of fees, public contributions and private donations. These funds are held in a trust fund under DAGS. The commission has been extremely fortunate to receive an annual grant appropriation from the Hawaii Tourism Authority in which a portion of the funds are used for the salaries and fringe benefits for these positions. This trust fund had a substantial balance; however, over time the corpus of fund slowly diminished. This fund provided a safeguard for our staff to ensure payroll is made between each HTA grant cycle.

They're a number of factors for the diminished funds, the economy, the higher costs/expenses for celebration events, lack of funding resources, etc...; unfortunately, we've been just advised that the trust fund balance is now at zero. This is the biggest challenge the commission is facing and one of several issues that I am trying to resolve since being named as the chair in November. Adding "State" funds is just option to help resolve an important need for the commission. The commission cannot survive without its staff and since these positions are exempt state employees; the staff cannot work without a salary. It is my hope that this legislative body can assist the commission in seeking funding alternatives for these positions.

On a side note, one factor that cannot be ignored is the composition of the commission. Again from my point of view, once general funding was eliminated, either the State or maybe the Commission should have looked at the composition of the commission and make changes to bring on individuals with business, philanthropy, marketing, fund-raising and banking background. This simple change could have cultivated or build, over the last 10+ years, a strong and solid financial base for the commission.

Aloha mai kākou

I am writing in support of SB 235, which seeks to: 1) add as a member, a representative of the Daughters of Hawai'i; 2) change the representation of the appointed, non-organization representatives on the commission from residents of the islands of Kauai, Maui, Molokai and Hawaii to residents of the counties of Kauai, Maui, and Hawaii; repeals the commission's authority to appoint an arts program specialist, and instead authorizes the commission the authority to appoint an executive director; and requires the executive director and clerk typist salaries to be provided, in part, by the State.

These provisions of the bill are merited in recognition of the growth of the celebration since 1871 when King Kamehameha proclaimed June 11th to be King Kamehameha Day in honor of his Great Grandfather Kamehameha the Great who united the Hawaiian Islands in 1810 and since 1872, several days in June are set aside to celebrate with floral parades, concerts, arts and crafts and feasting on all of the Hawaiian Islands.

From it's humble beginnings with horse and foot races at Kapiolani Park through current day festivities on all of the islands, the celebrations of King Kamehameha have grown. The King Kamehameha Celebration is a signature event for Hawai'i. Today, parades and cultural activities on Hawaii, Maui, and Kauai are attended by thousands of visitors. Since joining the commission in April 2012, I have observed the organization and planning needs of the Commission. The Arts Program Specialist is a misnomer since the work that this person does is comparable to that of an Executive Director. Changing the representation of the neighbor islands to residents of the counties of Kauai, Maui and Hawai'i also make sense and brings into conformance actual practices. Adding the Daughters of Hawai'i would enhance the involvement of a key Hawaiian Society involvement in the celebration. The Chair of the KKCC can expound on our reasons for advocating these changes.

Funding by the state is critical to the continuance of this event and recognizes the state's commitment to this event when it created it. Further, the celebration provides that cultural component that visitors look for when visiting Hawai'i and thus helps to build the state's economy. Compared to the benefits that the State reaps from this event, the request for funding is small.

Accordingly, urge your committees to pass this bill.
