SB 237 - Relating to Public School Lands

Chair Tokuda, Vice Chair Kidani, and members of the Committee:

Thank you for the opportunity to support Senate Bill 237 (SB237). The bill would enable a public-private partnership that allows the Department of Education to lease underutilized lands to generate income to be used to upgrade existing schools or construct new schools. The Governor supports the purpose of the bill but prefers the Governor's bill, Senate Bill 1096 (SB1096), as a vehicle for redevelopment of public school lands to support 21st century schools.

As Governor Neil Abercrombie mentioned in his State of the State address, "our public schools are on average 65 years old, and many facilities have been ignored due to limited budgets. That means students learning in structures that do not reflect our modern information and technology age." A public-private partnership described in SB237 and SB1096 "builds long-term value for local school communities, which benefit from better school facilities, multi-purpose community centers, workforce housing, or other needs as determined by a cross-section of the community."

"Success will require a community-based policy and planning approach. Any use of public lands must be compatible with and provide benefits to the surrounding community. Teachers, administrators, students, parents, community residents and other stakeholders (must) play a meaningful role in the planning, design and partnership between the school and its surrounding community."

The Governor looks forward to the continued dialog about this promising initiative.

Department's Position:

The Department of Education (DOE) supports this bill. The DOE appreciates the challenges in bringing our schools up to 21st Century standards and the costs involved in such an undertaking. Because this bill creates a three (3) year pilot program, it presents an opportunity to analyze options that may be available to create a new revenue source for new school construction.

Because the Lieutenant Governor shall serve as the facilitator of the pilot program, the DOE will work closely with the Lieutenant Governor to determine the most appropriate options to identify DOE schools that would be deemed appropriate as signature projects for this pilot. The DOE supports the creation of a school facilities special fund administered by the DOE into which any proceeds from this pilot will be deposited. These funds are to be used for new construction, upgrade of twenty-first century school facilities and repair and maintenance of existing school facilities.

The DOE believes that the provisions of this bill will enable the DOE to take advantage of all options available to it as it strives to align our facilities with 21st Century learning concepts, which will in turn establish the blueprint for the entire DOE inventory.

Dear Chair Tokuda, Vice-Chair Kidani and members of the Committee:

The Hawaii Institute for Public Affairs **supports** Senate Bill 237, which would establish a three-year pilot program within the Office of the Lieutenant Governor to allow for the limited lease of public school lands and facilities under the authority of the Department of Education to generate revenue for the school facilities special fund.

By way of background, in 2009, HIPA initiated the 21^{st} Century Schools Initiative, a research and communitybased effort to develop an innovative, systemic, and practicable approach to upgrade and construct 21^{st} century schools on a statewide basis. Recognizing that public funds are severely limited, HIPA is currently engaged in a public-private partnership with the Department of Education and various stakeholders centered on the following outcomes:

- Developing a new revenue source for new school construction and modernization of 21st century schools;
- Initiating a statewide rebuilding and modernization of Hawai'i's aging public schools that foster 21st century teaching and learning;
- Engaging and empowering more than 181,000 students, nearly 14,000 teachers, all communities statewide, and thousands of key stakeholders to support and improve school facilities in Hawai'i;
- Creating approximately 200,000 construction, maintenance, and similar jobs with urban redevelopment and public-private partnerships using vacant and underused public school lands (estimate courtesy of Rebuilding America's Schools Coalition);
- Facilitating statewide urban renewal and provide sources for economic development and security in all communities, while promoting sustainable economic development;
- Ensuring a fair and equal distribution of new revenue sources through a system-wide long-range plan for rebuilding Hawai'i's public school facilities; and
- Lifting student achievement, including among disadvantaged populations in underserved communities.

Pilot projects for this initiative are essential. We strongly agree with the need to test and evaluate development, design and financial models, and to give communities the opportunity to provide input and understand the concept of 21st century learning and facilities. We also respectfully encourage this Committee to add enabling legislation that would also create a systemic approach to modernize the entire system. The pilot projects can occur simultaneously with a system-wide plan, which, for all intents and purposes, will take two to three years to be established and implemented in any event. Once the pilot projects are completed during that period and learning and best practices are evaluated, the State will be in a position to implement this program on a statewide basis.

HEPC supports the wise and productive use of unused land that is not currently of use for departmental public education.

HEPC respectfully suggests that your committee consider that the leasing of such land to a charter school's affiliated nonprofit organization could be designated as a high priority.

Forging a partnership with nonprofits that support charter school facility needs would be a very cost effective strategy to supplement public school capacity and provide facility support for charters. HEPC notes that the estimated cost of a new HIDOE school on Maui is \$130 million. This is in contrast to a number of nonprofits assisting charters who estimate their costs of a new campus at approximately \$10-13 million.

This testimony is submitted in support of SB237 with suggested amendments.

The Hui for Excellence in Education (HE'E) is a diverse coalition of over 40 parent and community organizations dedicated to improving student achievement by increasing family and community engagement and partnerships in our schools. Our member list is attached.

The Coalition has been following the issue of our aging facilities and the need to find creative solutions to finance and rebuild our schools. The Coalition has hosted several speakers discussing 21st Century School design, mainland efforts to address school facilities, and local organizations working to find creative options. We are very pleased to see the legislature support the concept of using underutilized school lands to fund new school construction statewide through a Pilot Program.

We would ask that the Committee consider the following amendments in moving the bill along:

- Specify that the pilot program include the development of design specifications for 21st Century Schools to be used as a template for future campuses
- 2. Specify that school and community engagement be a required component of the Pilot Project both in the design and development of new schools and in the proposed uses on the leased lands
- 3. Specify that uses on the underutilized school lands be compatible with surrounding land use and zoning (some school property may need zone changes to be redeveloped and the proposed zoning should be compatible with the surrounding existing zoning designations)

- 4. Specify that early learning centers along with K-12 facilities could be included in the Pilot Program.
- 5. Request that the lieutenant governor's report include information on school and community engagement efforts in the pilot program.

We would be glad to work with the legislature, department, board of education, the lieutenant governor, and any other appropriate agencies to make this effort successful.

Thank you for the opportunity to testify and for your consideration.

Our support of this bill represents a 75% consensus or more of our membership. While the majority of the Coalition members supported this bill, Parents for Public Schools could not come to a consensus to support this position.

Honorable Chair Tokuda and committee members:

I am Kris Coffield, representing the IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 150 local members. On behalf of our members, we offer this testimony <u>in support of</u> Senate Bill 237, relating to public school lands.

On average, Hawaii's public school buildings are over 65 years in age, with the state's per-capita capital improvement spending ranking last in the nation. No one should have been surprised, then, when the roof of Farrington High School's auditorium collapsed due to a combination of degradation and design flaws. Given the dearth of funds available for infrastructure improvements on public school campuses throughout the state, as well a relative lack of affordable and workforce housing, we support this initiative, which establishes a pilot program that seeks to generate revenue for school improvements through the leasing and optimization of unused public school lands, with development priority being given to workforce rental housing projects. Moreover, we note that this measure address concerns raised by the DOE in previous years with regard to similar proposals by decreasing the number of piloted leases from ten to two, while appropriating funds for necessary preparations, including feasibility studies and the evaluation of site-specific requests for proposals (though these two cost items are not specifically enumerated in the appropriation request).

That said, we also note, with prior City and County of Honolulu administrators, that the rental units foreseen by this bill revert back to the DOE after the lease term ends. If the DOE should continue to rent the units after this point, the respective counties in which the developments are built will not receive any further property taxes on the land. <u>Both the truncation of property taxes to the counties and potential lack of expertise regarding building, and specifically workforce rental housing, management may need to be addressed by the committee as the measure moves forward during the legislative session. After all, no one wants to unnecessarily encumber management of the DOE's already strained infrastructure portfolio or see the roofs of workforce rental housing collapse because of decades of neglected maintenance.</u>

I am testifying in support for Senate Bill 237, Relating to Public School Lands

Since 1999, ASCE has prepared reports on the state of the nation's infrastructure, including schools. The 2009 report graded schools at a "D". An earlier 1999 report by the General Accounting Office estimated one third of the nations schools are in need of repairt estimated at \$112 billion. Although there is no comprehensive federal report on the condition of schools, it is clear the schools in Hawaii are faced with a long list of repairs and renewals based on the Department of Education maintenance backlog of projects. Surveys conducted by the National Center for Education Statistics determined the extent to which environmental conditions of old facilities contributed to interterence to classroom instruction.

Among the many solutions recommended by ASCE, the financial shortfall could be assisted by encouraging school districts to explore alternative financing, including lease financing and financing/ownership/use arrangements to facilitate construction. Hawaii should urge Congress to continue and increase federal grants for high-poverty, high-need school districts.

Senate Bill 237 would provide a three-year pilot project to generate revenues through the lease of public school lands. The revenues would be deposited in a School Facilities Special Fund dedicated to new construction and upgrades as well as repairs and maintenance of schools. Funds should be managed through the use of life-cycle cost analyse principles to evaluate the total cost of projects.

We strongly urge your support for Senate Bill 237. Thank you for the opportunity to testify on this important legislation for the improvement of our educational system.

TESTIMONY COMMENTING ON SB 237

Aloha Chair Tokuda and Members of the Committee:

The Sierra Club, Hawaii Chapter, with over 10,000 dues paying members and supporters statewide, offers the following *comments* regarding SB 237. This measure establishes a program to develop and lease school lands in order to generate revenue for educational purposes.

It is outside the purview of the Sierra Club to comment to address the educational value of this measure.

To the extent this measure has been compared to the Public Lands Development Corporation, we encourage this Committee to carefully ensure that public participation, transparency, and accountability are built into this measure. SB 237, for example, should require all transactions be subject to the procurement code so as to ensure fair bidding and an open process. And require there be public disclosure of any proposed actions to the impacted schools/communities and an open hearing process.

We recognize the actions being proposed may sometimes be contentious, but there is no shortcut to public involvement. Difficult conversations must be had to ensure we're building the type of collaborative and inclusive communities that we all want to live in.

We appreciate this measure does not propose any exemptions to existing land use and environmental laws. We ask the Committee not to alter this commitment.

Dear Chair Tokuda, Vice-Chair Kidani and members of the Committee:

I am professional land planner and I attended Kuhio School in Moiliili, and I support Senate Bill 237, which would establish a three-year pilot program to allow for the limited lease of public school lands and facilities under the authority of the Department of Education (DOE) to generate revenue for a school facilities special fund. Such a fund is a critical component of this effort as it will ensure that any revenue generated on public school lands "...will be used to build or upgrade twenty-first century school facilities."

On December 6, 2012 I attended a presentation by the Hawaii Institute of Public Affairs to the Hawaii Chapter of the American Planning Association on the 21st Century Schools Initiative, a forward-thinking approach to upgrade and construct 21st century schools on a statewide basis. I learned of the astounding amount of capital improvements funds that are spent on repair and maintenance of our aging schools each year. I am troubled that our students do not have the proper facilities to be prepared for global competition in the 21st century.

As a professional planner for 30 years, I have always noted that there are many school sites on Oahu that are located on valuable land, which, with public input and sensitively-designed development, could either: 1) generate more income for public schools, and 2) create more up-to-date and relevant school facilities.

Given the possibility of public skepticism, pilot projects for this initiative would demonstrate their potential for application to other public school sites. I respectfully encourage this Committee to give favorable consideration of SB237. We really don't have another alternative for a massive overhaul of public school facilities on the horizon.

About 10 years ago, the United States Pacific Command spent a significant amount of federally appropriated monies to build a computer lab for Radford HS. This project entailed upgrading the electrical "backbone" because Radford, along with most other school campuses, was not built to handle the electrical requirements for this lab.

Additionally, the average age of the schools that serve the Joint Base Pearl Harbor Hickam community is 55 years. Building 21st Century Schools under a public-private initiative is a bold and innovative way to provide our keiki with the school facilities they need so they can compete in the 21st Century economy.
