Aloha Honorable Chair Cindy Evans and members of the House Committee on Water and Land,

Thank you for the opportunity to provide testimony in support of SB2391 SD2 which would establish a pilot project to resolve user conflict on public recreational lands.

Conflict between various users of recreational areas will continue to escalate with the increase of tourism to our State. Commercial operators and tour groups promise visitors "new" experiences outside the traditional tourist agenda, a trend which leads them into residential communities, as well as to significant cultural and recreational sites for many local residents.

Examples of this trend span across the State. Formerly quiet beachside, residential roads in Waimanalo are now scattered with large tour buses and commercial tour vehicles, often times idling, in front of private homes. Community parks and beaches across the State serve as satellite storefronts for non-permitted, unregulated commercial operations. There has been a steep rise in confrontations between commercial boat operators and fishermen at Poho'iki and Keauhou on the Big Island. A Hawaiian charter school in Haiku located on DHHL land at the base of a popular, but "closed" hiking trail are faced with trespassers through school property every single day. Then there is Kailua; historically, user conflict can be traced back over 25 years through archived neighborhood board minutes, and the problem still persists today despite ongoing efforts of residents, community groups, and recently passed City ordinance. Incidents such as these are the cause of anguish for many local residents which will consequentially spillover into the visitor experience. Those of you who represent districts near public recreational areas have surely received complaints from your constituents, and likely have experienced negative encounters yourselves.

Many communities are seeking relief and deserve balance. Our finite natural resources need protection. Please pass bill 2391 in order to develop a statewide set of management strategies and tools to prevent and resolve conflict on public recreational lands. Although solutions may be unique to each situation, a project such as this will provide a baseline to which various agencies of our government can effectively communicate, collaborate, and ensure that all involved are working cohesively. This will also assure various rules of each department, regardless if they fall under the City or State, are compatible and support one another in cases where multiple agencies share jurisdiction.
