Title of Bill: SB 0239 RELATING TO EDUCATION

Purpose of Bill: Moves the framework for establishing an annual conference of secondary school students from chapter 317, HRS, to chapter 302A, HRS. Removes the governor's authority to appoint members of the student conference committee. Clarifies that the student conference advisory committee will provide guidance to the student conference committee in carrying out its purpose and duties. Repeals the mandatory legislator and department of education membership and instead clarifies that the department of education shall maintain guidelines and procedures for selecting the student conference is subject to program and funding limitations and removes the three day limit. Repeals the requirement for an evaluation report on student conference proceedings. Repeals chapter 317, HRS.

Department's Position:

The Department of Education supports SB 239. It provides much needed clarity to Hawaii Revised Statutes Chapter 317 in regards to the framework and advisory committee's role for the annual conference of secondary school students. This bill also repeals the requirement of an annual evaluation report of the student conference proceedings.

SUBJECT: Support Senate Bill No. 239

As a Hawaii State Student Council (HSSC) representative for the last three years I have witnessed the effective implementation of the annual Hawaii Secondary Student Conference (SSC) and the positive impact it has had on the student delegate attendees. Therefore, I submit this testimony in support of Senate Bill No. 239 on behalf of the HSSC with the belief that SSC should continue to serve as a legislative opportunity for young adults in Hawaii.

For many years, the HSSC and SSC Planning Committee have maintained a positive and cooperative working relationship. Each year, one HSSC representative from each public school district has been provided the opportunity to attend SSC. Together these representatives have served as a body of support for the public school students of Hawaii, writing resolutions concerning statewide student concerns and testifying on the students' behalf. In addition, HSSC has provided a member from the Council to serve as a liaison on the SSC Planning Committee.

After returning to SSC in 2011 for a second legislative opportunity, I felt that the conference was in need of internal improvements to strengthen the delegate experience. Past state conferences had yielded poorly written resolutions with insubstantial research, which negatively reflected on Hawaii's young adults. However, with the recent implementation of research investigative strategies as a means of encouraging more in depth background explorations, resolutions have shown considerable improvement.

Each year the SSC Planning Committee, consisting of student leaders and adult advisors, evaluates the planning and execution of the conference as a whole. Through late night evaluation sessions that take place every evening of SSC, the Planning Committee has identified flaws in the implementation of the conference. However, such evaluations have resulted in stronger and more effective conferences in following years. As the SSC program undergoes extensive changes and reforms this school year, HSSC believes that it will continue to prosper as a positive program for the students of Hawaii. As a public service and legislative experience, SSC will persist in its efforts to encourage the youth of Hawaii to take a greater and more substantial role in civic action.
