# A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. To maximize agricultural production, the 1 2 legislature finds that Hawaii must create a coordinated plan to 3 provide research, educational opportunities, services, and 4 resources to assist new and existing agricultural businesses to 5 thrive and grow. Accordingly, the purpose of this Act is to 6 reduce imported foods and satisfy the goals of the Increased 7 Food Security and Food Self-Sufficiency Strategy, adopted by the 8 office of planning and implemented by the department of 9 agriculture, and to enhance Hawaii's diversified agricultural 10 industry. The program established pursuant to this Act will 11 identify food and emerging crops, identify resources and 12 technologies to sustain food crops and new agricultural 13 industries, and establish an educational program to prepare and 14 produce successful agricultural entrepreneurs and a 15 knowledgeable workforce.

Requires the Agribusiness Development Corporation and the Department of Agriculture to develop a coordinated land management strategy to promote diversified agriculture, support emerging and specialty crops, and maximize agricultural development. Requires the Agribusiness Development Corporation, the Department of Agriculture, and the University of Hawaii College of Tropical Agriculture and Human Resources to coordinate and provide technical support to farmers to identify emerging and promising crops and support and cultivate successful agricultural businesses.
