S.B. 2589, S.D. 2 RELATING TO LAW ENFORCEMENT

House Committee(s) on Transportation & Public Safety

The Department of Transportation (DOT) **supports** the intent of this bill, which proposes to establish a Hawaii State sheriff, Harbors Division, and to transfer functions and authority exercised by the Department of Transportation relating to harbors law enforcement to the Department of Public Safety, effective July 1, 2016.

The intent of the bill is to further the discussions regarding the transfer of law enforcement functions to the Department of Public Safety. Concurrent to the discussion on this bill, there are on-going discussions and future negotiations of the newly formed Bargaining Unit 14. The effective date of July 1, 2016 provides the Union the opportunity to elect its leadership and provide the State and Union the opportunity to present testimony before the Legislature. The proposed date also permits the parties to negotiate the impact of the transfer to the employee's wages, hours, and working conditions.

Chairs Yamane and Har and Members of the Committees:

The Department of the Attorney General provides the following comments.

This bill transfers the law enforcement functions of the Department of Transportation (DOT), Harbors Division, to the Department of Public Safety (PSD).

First, section 3 on page 7, lines 5-21, through page 9, lines 1-3, provides for an amendment to section 266-29, Hawaii Revised Statutes, which is the authorizing and enabling statute for the state harbors civil violation system. The new subsection (e) being added to section 266-29, on page 9, lines 1-3, provides that "[e]ffective July 1, 2016, the enforcement of this section shall be under the jurisdiction of the department of public safety." This wording should be clarified. It is not clear whether the PSD will be responsible solely for the "law enforcement" functions such as the power to issue citations, and the DOT will remain responsible for the "administrative" functions that includes such responsibilities as adopting, amending, and repealing the applicable rules as well as processing the citations through administrative hearings. If this is the intent, wording should be added to more specifically identify the duties being transferred to PSD.

Second, as written, the wording on page 5, lines 6-7, and page 10, lines 17-18 specifically requires that "[t]here shall be established a harbors division within the department of public safety." We suggest deleting this wording to allow the PSD flexibility to effectively and efficiently integrate the functions of the transferred harbors division personnel into the Law Enforcement Division of the PSD.

The Department of Public Safety (PSD) supports this bill, which transfers the

law enforcement functions of the Harbors Division of the Department of

Transportation to PSD. The current employees of the Harbors Division would be

able to take advantage of the training and support from the Sheriff Division, a

significantly larger organization. This transfer would improve the level of

effectiveness of law enforcement at the harbors.

As this bill is written, it would require PSD to establish a Harbors Division

within the PSD. This requirement is found in Section 1, on page 5, lines 6 and 7;

and on Section 4, on page 10, lines 17 and 18. We request that this requirement be

deleted so that we may be allowed to best integrate the function of the Harbors

Division into the Law Enforcement Division of PSD.
