Allows all-terrain (ATV) and utility-terrain vehicles (UTV) to be driven on any street as farm equipment under certain conditions. Establishes a penalty for violation. (SD2)

Chair Representative Karl Rhoads, Vice Chair Representative Sharon E. Har, and Members of the Committee:

My name is Alex Franco I'm President of the Hawaii Cattlemen's Council (HCC). HCC is a statewide umbrella organization made up of five county level Cattlemen's Associations that represents 130 members involved in the cattle industry in Hawaii.

The Hawaii Cattlemen's Council **<u>supports</u>** SB 2726 SD2 as it allows farmers and ranchers to utilize ATV's and utility-terrain vehicles to legally travel on the public roads to go from one pasture, field, or TMK to another. Many farms and ranches here in Hawaii are split up by public roads, and by having the ability to utilize what is already an important piece of farm equipment in the field to also travel to other parcels split up by these roads makes it more multipurpose and efficient, helping farmers to keep their cost under control.

Provisions with in the Bill will limit use of ATV's and utility-terrain vehicles to bona fide farmers and ranchers within small Agricultural based communities which they live, work, and are involved in on a daily basis.

S.B. 2726, S.D. 2 RELATING TO TRANSPORTATION

House Committee on Judiciary

The Department of Transportation **supports** this S.D. 2 version of the bill to allow all terrain vehicles to be operated as farm equipment on streets as defined in 291C-1, Hawaii Revised Statutes (HRS), but recommend that it be further amended.

In subsection (a), paragraph (1) of the bill, it states that all-terrain vehicles will be operated as farm equipment, but they are not included in the definition of farm equipment. It is recommended that they be included in the definition, because the same vehicles can also be used for recreational purposes, such as hunting and fishing. To ensure that the vehicles are used on public roads only in association with farming activity, farmers should be required to declare the specific locations where they will use the vehicles on public roads, obtain a permit for use and be required to carry the permit whenever driving on a public road. It should also be clear that the vehicles are to be used only when driving between personally owned noncontiguous properties zoned for agriculture.

Since these vehicles are manufactured for off-road use only, their use on public roads is a potential hazard for drivers of licensed and insured vehicles. It is suggested that 291-36(d) be reviewed for wording to provide the permit issuing authority as well as other highway users in registered and insured vehicles with indemnity for any injury or property damage resulting from off-road vehicle operation on public roads.

RE: Senate Bill No. 2726, SD2- Relating to Transportation

Dear Chair Rhoads and Members of the Committee:

The Maui Police Department opposes the passing of Senate Bill No. 2726, SD2, which allows all-terrain vehicles (ATV) and utility-terrain vehicles (UTV) to be driven on any street as farm equipment under certain conditions.

The Maui Police Department understands the use of all-terrain and utility-terrain vehicles as a helpful and productive tool for farming and agriculture; however, the risk for injury and the potential safety and traffic concerns should not be overlooked. The ATVs and UTVs have little safety equipment to protect the operator and, due to their small size, may be overlooked by motorists and pedestrians. This bill, as it is currently written, will also make it difficult for officers to enforce and to determine whether or not the ATV or UTV is actually being used as farm equipment.

The Maui Police Department also recognizes the suggestion brought up by the State of Hawaii Department of Transportation, regarding establishment of a permit identifying route, time of travel, and validity period. This will make it easier for officers to enforce and create a clear distinction between vehicles used for farming and those used for other purposes.

The Maui Police Department also agrees with the suggestion by the State Department of Transportation to define ATVs and UTVs to be used specifically for farming as farm equipment and not motor vehicles. Otherwise, ATVs and UTVs would fall into the definition of a motor vehicle under HRS §291C-1, and should be registered, insured, be regularly inspected for safety and possess a license plate like all other motor vehicles operating on a public roadway. Smaller ATVs may conform to the definition of a "moped" under HRS §291C-1, by having a maximum engine displacement of 50 cc's; however, most UTVs would not, and therefore, would be required to conform to the same requirements as any other motor vehicle being operated on a public roadway. Another concern would be the issue of liability in the event of an accident while an ATV or UTV is being operated on a street. If an operator, who has access to farm land, gets into an accident while using an ATV or UTV for recreational purposes, it would difficult to prove that the ATV or UTV was being utilized illegally should the operator claim that they were using the vehicle for farm purposes. This would cause liability issues, especially in situations of injury or major property damage.

Due to these concerns the Maui Police Department opposes SB 2726, SD2.
