Chair Luke, Vice Chairs Nishimoto and Johanson, and Members of the Committee:

The Department of Public Safety (PSD) supports SB 2884, SD 2 Relating to

Parole. This bill clarifies the responsibilities and duties of the Hawaii Paroling Authority

when granting funds to offenders who are exiting the correctional system, and are being

discharged from parole. It is PSD's belief that it is the ex-offender's right to be

considered for a pardon after five years under parole supervision. Section 353-72,

Hawaii Revised Statutes, ensures that every pardon application would be investigated.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB2884 SD2, which allows the Legislature to specifically fund the disbursement of "gate money" to offenders who have fulfilled their debt to society, in order to facilitate their access to basic necessities critical for successful reintegration.

In 2010, OHA produced a comprehensive report detailing the disparate treatment of Native Hawaiians in the criminal justice system. Since then, OHA has administered the Native Hawaiian Justice Task Force (NHJTF), which was tasked by the Legislature to address this multi-faceted issue. The need for improved services and opportunities for pa'ahao reintegrating into their communities was a central theme for the NHJTF.¹ During its seven public pae 'āina community meetings, the NHJTF received much testimony regarding the immense challenges pa'ahao face as they reenter society.² The testimony highlighted the critical need for programs and services to ensure that those reintegrating could acquire basic necessities, access mental health and medical services and enroll in transition programs. Accordingly, a small amount of "gate money" upon their release from prison may help reintegrating offenders obtain state identification and vital documents, use public transportation and attend health programs and career related services. By reviving the disbursement of "gate money"—which was formerly provided under a discontinued but much-needed program—to pa'ahao who have fulfilled their debt to society, this bill will greatly facilitate their successful reintegration into the larger community.

Therefore, OHA urges the Committee to **PASS** SB2884 SD2. Mahalo for the opportunity to testify on this important measure.

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, community initiative promoting smart justice policies for more than a decade. This testimony is respectfully offered on behalf of the 5,800 Hawai`i individuals living behind bars, always mindful that approximately 1,500 Hawai`i individuals are serving their sentences abroad, thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral lands.

SB 2884 SD2 specifies that funds for discharged persons are subject to legislative appropriation and clarifies circumstances under which the paroling authority may grant early discharges. Provides discretion to the paroling authority with respect to initial pardon consideration as it relates to paroled prisoners. Effective 07/01/2050.

Community Alliance on Prisons supports this measure.

Hawai'i used to give 'gate money' to individuals just released on parole. This practice was discontinued and is no longer available. People exiting incarceration need a helping hand to reintegrate back to their communities. A few hundred dollars can make all the difference in someone's successful transition from institutional to community life.

Please vote yes to pass these three measures to improve our corrections strategies to make our community safer and healthier.

SB 2308 SD1 Relating to Children would give the department of public safety funding to assist the children of imprisoned parents and help with family reunification for imprisoned people. We have done research and written on the importance of assisting children and families deal with the effects of incarceration on their lives. A paper we wrote is forthcoming in a book being edited by law professors Tali Gal at Haifa University, Israel, and Benedetta Faedi Duramy at Golden Gate University, California, being published by the Oxford University Press. Also research on criminal desistance by Dr. Shadd Maruna, Queen's University, Ireland, discussed in his numerous publications including *Making Good: How Ex-Convicts Reform and Rebuild Their Lives* shows how vital it is for the rehabilitation of people in prison to make amends with family.

SB 2315 SD1 Making an Appropriation for the Department of Public Safety to Provide Substance Abuse Treatment Services would provide funding for drug and alcohol treatment at Halawa prison. It is common knowledge well supported by research that the motivation for many crimes is substance abuse. This appropriation is absolutely necessary for the protection of our community.

SB 2884 SD2 Relating to Parole makes clear that funds may be provided for people leaving incarceration and clarifies other parole matters. This measure is also in the best interests of our community.

All three measures are a step in making our corrections system more effective for rehabilitation, which makes our community safer and healthier. The Hawaii Paroling Authority (HPA) strongly supports SB 2884, SD2 and urges the legislature to move this measure forward and amend the effective date from July 1, 2050, to July 1, 2014.
