Chair Aquino, Vice Chair Ing, and Members of the Committee:

The Department of Public Safety (PSD) **supports** SB 2884, SD 2 Relating to Parole. This is an Administration bill that clarifies the responsibilities and duties of the Hawaii Paroling Authority, as they relate to three areas. First, this bill clarifies that HPA may provide gate money to offenders who are exiting the correctional system if there are appropriations. Second, this bill clarifies that certain offenders are not to be discharged from parole. This specifically includes those who are still serving any portion of a mandatory minimum, and those who have not yet fulfilled their restitution obligations.

Third, the current law may be read to require the HPA to consider for pardon, every person who has been on parole for five years. This bill would give the HPA discretion as to whether a pardon should be considered at that point.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB2884 SD2, which allows the Legislature to specifically fund the disbursement of "gate money" to offenders who have fulfilled their debt to society, in order to facilitate their access to basic necessities critical for successful reintegration.

In 2010, OHA produced a comprehensive report detailing the disparate treatment of Native Hawaiians in the criminal justice system. Since then, OHA has administered the Native Hawaiian Justice Task Force (NHJTF), which was tasked by the Legislature to address this multi-faceted issue. A copy of the NHJTF 2012 legislative report and related materials are available at: www.oha.org/nativehawaiianjusticetaskforce.

The need for improved services and opportunities for pa'ahao reintegrating into their communities was a central theme for the NHJTF.¹ During its seven public pae 'āina community meetings, the NHJTF received much testimony regarding the immense challenges pa'ahao face as they reenter society.² The testimony highlighted the critical need for programs and services to ensure that those reintegrating could acquire basic necessities, access mental health and medical services and enroll in transition programs. Accordingly, a small amount of "gate money" upon their release from prison may help reintegrating offenders obtain state identification and vital documents, use public transportation and attend health programs and career related services. By reviving the disbursement of "gate money"—which was formerly provided under a discontinued but much-needed program—to pa'ahao who have fulfilled their debt to society, this bill will greatly facilitate their successful reintegration into the larger community.

Therefore, OHA urges the Committee to **PASS** SB2884 SD2. Mahalo for the opportunity to testify on this important measure.

Chair Aquino, Vice-Chair Ing, and members of the House Committee on Public Safety, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in **<u>support</u>** of Senate Bill 2884, S.D. 2.

S.B. 2884, S.D. 2, would clarify the Hawai'i Paroling Authority's ("HPA") ability to grant written discharge from further liability on a prisoner's sentence, to the extent that the prisoner is serving a court-ordered mandatory minimum, and/or continues to owe restitution payments to his or her victim(s). These are reasonable limitations, which recognize the authority of court-ordered mandatory minimums and protect the interests of crime victims. While the HPA is likely already adhering to these limitations currently, the express clarification of this statute is both helpful and appropriate.

For these reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu supports S.B. 2884, S.D. 2. Thank for you the opportunity to testify on this matter.

This testimony is respectfully offered on behalf of the 5,800 Hawai`i individuals living behind bars, always mindful that approximately 1,500 Hawai`i individuals are serving their sentences abroad, thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral land.

SB 2884 SD2 specifies that funds for discharged persons are subject to legislative appropriation and clarifies circumstances under which the paroling authority may grant early discharges. Provides discretion to the paroling authority with respect to initial pardon consideration as it relates to paroled prisoners. Effective 07/01/2050.

Community Alliance on Prisons supports this measure.

Hawai'i used to give 'gate money' to individuals just released on parole. This practice was discontinued and is no longer available.
