SB 2953 SD 1, RELATING TO STATE RESOURCES ON HAWAIIAN HOME LANDS

Aloha Chair Evans, Vice-Chair Lowen, and Members of the Committee:

The Department of Hawaiian Home Lands (DHHL) is in support of this bill which provides the department funding from geothermal royalties from potential geothermal projects on Hawaiian home lands.

DHHL welcomes this source of revenue to support the department's programs including homestead lot development, loans, rehabilitation programs, and administration expenses to support these programs. In consideration of the limited general funds appropriated to the department and the conclusion of the Act 14 settlement payments, the passage of this measure allows for DHHL to receive royalty payments when geothermal resources are developed on Hawaiian home lands.

While we support the intent to provide resources to DHHL, we believe the department should receive 100% of these royalties given that they are generated from resources that lie within our trust lands. That said, we do acknowledge that the Department of Land and Natural Resources depends on its share of the geothermal royalty payments to regulate and administer the mining leases and the

development of geothermal resources. We ask your committee to consider allocating all of the royalties from geothermal projects on Hawaiian home lands to DHHL with a portion of the royalties to be paid to the Department of Land and Natural Resources for the purpose of administering this program.

Re: SB 2953 RELATING TO STATE RESOURCES ON HAWAIIAN HOME LANDS.

Specifies that twenty per cent of royalties from geothermal resources on DHHL lands shall be paid to the DHHL and twenty per cent shall be paid to the county in which the geothermal resources are located.

Testimony in opposition

Our state Constitution specifies that all mineral and geothermal resources are reserved to the State of Hawaii regardless whether those resources are located on government or private lands.

So far as I am aware there are no laws awarding percentages of revenue to the county or agency which administers the land from which the revenues are derived. Royalties from geothermal resources should be deemed to be part of the revenues derived from the land and not segregated according to the county or agency controlling that land.

If windmills on state land in Kahuku generate royalties from the electricity they produce, would the state then feel compelled to give a portion of those royalties to the City and County of Honolulu, and/or to the DLNR?

If royalties are earned from piping up deep sea water offshore Kona, bottling it, and exporting it to Japan, would the state then feel compelled to give a portion of the royalties to the Hawaii County Council, and/or to DLNR?

Let's not start subdividing state lands or fractionating the royalties they generate.
