Re: SB 3012

Position: Opposition.

This measure mandates health care providers to provide medical records to patients for a flat rate of \$15.60 or the amount currently approved by the Social Security Administration, whichever amount is greater, if the request is for the purposes of a claim or appeal under any provision of the Social Security Act, or for free.

A more common standard would be to allow a fee of 1 dollar per page for the first 25 pages and a fee of 25 cents for the rest of the needed pages.

The HMA opposes this bill because some medical charts are up to 500 pages and it takes a considerable amount of staff time to retrieve files that may be in storage. There is national recognition that a reasonable fee is a dollar a page for at least the first 25 pages.

My name is Michael Robinson, Executive Director, Philanthropy & Government Relations for Hawai'i Pacific Health (HPH). We are committed to the timely production of patients' medical records. However, supplying a patient with this type of information is not just a matter of accessing a file and copying the material. Because of the sensitivity and complexity of the information, healthcare providers like us use the assistance of medical records vendors to manage medical records for which there is an associated cost. Thus, we believe a nominal fee is necessary to off-set some of the expense the providers bear in making medical records available to the patients.

The Legal Aid Society of Hawaii submits testimony in support of SB3012 SD1 – Relating to Medical Records. This bill would allow access to copies of medical records at a flat rate or for free when an individual is applying for disability public assistance.

For those who are disabled and seeking support through the state's general assistance and AABD programs, medical records are required to support their claims of disability. This population generally has no income and are seeking financial assistance. When there are charges for medical records, some eligible clients are unable to receive the assistance that they need because they cannot afford the cost of the records. This bill would assist those seeking assistance get access to those records.

We understand that there are costs for medical providers associated with the retrieval of medical records. We believe that utilizing the flat rate which social security now uses is a reasonable compromise given the limited income available to those seeking financial assistance due to disabilities.
