## S.B. 3035, S.D. 1 RELATING TO CONSERVATION

House Committee on Transportation

The Department of Transportation (DOT) **supports** the intent of the bill. However, we feel this bill is not needed because we have started a shoreline erosion project that also addresses climate change for that segment of Kamehameha Highway at Laniakea Beach. This segment of Kamehameha Highway has been inundated by high surf, which has negatively impacted the safe, efficient and accessible highway system along this corridor.

The current project effort is on the development of a federal and State environmental assessment document. As part of the federal process we have been working with the community since May 2011, and expect to complete the federal and State environmental process in June 2015. The alternatives being considered, at this time, do include two realignments of Kamehameha Highway mauka of Laniakea beach.

Dear Chair Yamane, Vice Chair Takayama, and Committee Members,

My name is Stuart Coleman, and I am the Hawaii Coordinator of the Surfrider Foundation. With more than 5000 activists and supporters across the state, Surfrider strongly supports passage of SB 3035 SD1. Our members opposed the Department of Transportation's action of erecting barricades at Laniakea Beach support park because it blocks residents and tourists from parking at this popular beach. While we understand that traffic and safety issues, we believe the barricades are wrong and this bill would expedite a long-term solution.

Because our organization is dedicated to beach access, we support SB 3035 because it will provide funding through obligation bonds to build a bypass road around a wayside park. The bypass road and park will realign Kamehameha Highway mauka of the beach and do three key things: 1. Protect people crossing the road and reduce traffic congestion; 2. Improve beach access by providing more parking; and 3. Prevent the road from being washed out by big storm events and sea level rise.

With over 600,000 visitors annually, Lani's is one of the most popular beaches in Hawaii. Each day, scores of tour buses and vans and thousands of tourists stop by the side of the road to see the sea turtles, and this has caused serious traffic congestion and safety concerns in that area. But instead of putting up barricades to block off the entire area, this bill creates a by-pass road that will go around the mauka side of the City & County Support Park so that all of the beach parking will be on the makai side of the by-pass and no crossing of the road will be necessary.

Working with many North Shore residents and groups, we oppose DOT's plans to build a longer bypass road that would go through the Chun's neighborhood and require condemning parts of people's properties in that area and building bridges on either end of the bypass. The DOT's plan would take many years and millions of taxpayer dollars to build. Instead, we support the plan for a shorter road that goes around the existing support park land and wouldn't require building bridges or condemning people's properties. Dear Chair Yamane, Vice-Chair Takayama, and Committee Members:

I write in **STRONG SUPORT OF SB3035 SD1** introduced by Senator Clayton Hee, whose senate district includes the project area. The original version of this bill (the key provisions of which should be *re-inserted*) would establish a State wayside park at Laniakea and Chun's beaches on the North Shore of Oahu. The original bill proposed to put the Department of Land & Natural Resources (DLNR) in the lead on the planning and supplemental land acquisitions necessary to create a new "wayside" park in collaboration with the community and surrounding landowners -- particularly Kamehameha Schools, the State Department of Transportation (DOT), and the City and County of Honolulu.

The major purpose of the bill to ensure expeditious realignment of the stretch of highway near Laniakea Beach Park. But also to ensure a comprehensive solution an insufferable decade of unregulated visitor traffic and pedestrians haphazardly crossing Kamehameha highway. The lack of action by DOT has created a severe safety problem for residents and visitors, jammed up the highway for miles on virtually every weekend and now on weekdays (despite the barriers), and created havoc for the green sea turtles for which this beach is essential resting and foraging habitat. For over ten years, the community has patiently waited for a permanent solution. None has appeared despite a huge investment of community and agency time, money, goodwill, and energy. The new "temporary concrete traffic barriers" installed by DOT at the site are an embarrassing eyesore and certainly not a long-term solution.

The realignment task force led by DOT has languished for years and narrowly focused on the highway, without adequate consideration for the high natural resources, scenic, cultural, and recreational values of this area. Ten years ago, the City set aside several acres of land at Laniakea and Chun's for beach parks (which can provide critical site anchors for an overlay of a state wayside park) but the City's efforts to create these two support parks has also stalled. Kamehameha Schools (KS) has indicated its support for this new "state wayside park" approach. Even DOT has testified in support of SB3035's intent. The solution for this area must be a comprehensive **state-city-KS-community solution** – it can build on these prior efforts but should solve the problems in both adjacent areas with a single solution and must consider the impacts of climate change and beach erosion, already a significant problem in this area.

A state wayside park (such as the state has created at Nu'uanu Pali, La'ie Point, and Makapu'u) will be a fresh integrated approach, changing the focus from just "moving the highway mauka" (which seems to be an area of near-universal agreement) to a comprehensive solution that appropriately protects the high natural resource and scenic values of this area. A well-designed wayside park can provide a safe, controlled, and educational experience for visitors briefly passing through the North Shore, be a model for how state beach parks can be resilient and adaptive to climate change, and also give highest priority for local uses of the beaches of this area as well protecting turtle habitat.

Although the specific design is to be determined, the broad inter-agency and conaborative approach of the bill is critical to a successful solution for the severe traffic mismanagement problem that adversely impacts anyone going "circle island" as well as those who live on the North Shore.

Comments: Dear Chair Yamane and members of the committee: I am writing to you about SB3035, the proposal to fund and direct DOT to realign Kamehameha Hwy near Laniakea on the North Shore. I strongly support this bill and request that you pass it so that the full House can consider it. My apologies for submitting this testimony so late, but I have only just heard that your committee is scheduled to meet on it this morning. My reasons for supporting this bill are (a) that this area desperately needs traffic mitigation because the traffic congestion there is a serious problem both for local residents and for other residents of the island, and visitors, who wish to visit and enjoy much of the North Shore and (b) that the DOT "short term" solution (barricading off parking) is not only an aesthetic travesty of a beautiful beach area, but is highly likely to be found inadequate when Summer time leisure activities and tourist traffic return in full force. The original draft of this bill included planning for Chun's Reef and proposed that DLNR be the project lead, so that whatever is done manages the entire area, including creating park facilities for visitors. If let solely to DOT, the result is likely to be a narrow "transport only" solution, which would be greatly less than what could be done in this area. I would support the lead role in this activity being restored to DLNR. Mahalo for your consideration. - Beau Sheil Resident of Haleiwa
