Re: S.B. No. 328, S.D.1

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

S.B. No. 328, S.D.1, amends the landlord-tenant code to specifically allow a landlord to require a security deposit to pay for damages caused by an animal allowed to reside in a rental unit as a condition of a rental agreement.

The HCRC does not oppose S.B. No. 328, S.D.1, because it clarifies that a landlord may not require a security deposit for an assistance animal that is a reasonable accommodation for a tenant with a disability under HRS § 515-3(9).

Both federal and state fair housing laws require landlords and other housing providers provide reasonable accommodations in rules, policies, practices, or services when such accommodations are necessary to afford a person with a disability an equal opportunity to use and enjoy a dwelling. Under both state and federal fair housing laws, a reasonable accommodation for a person with a disability can include the use of an assistance animal. Pursuant to HUD's Handbook regarding subsidized multifamily housing programs and HCRC policy, a landlord may not require an applicant or tenant to pay a fee or a security deposit as a condition of allowing the applicant or tenant to keep the assistance animal. (See attached HUD Handbook 4350.3 § 2-44(E) and HCRC information sheet.) This is because the use of an assistance animal is a reasonable accommodation for a person with a disability; these assistance animals are not "pets."
