PURPOSE: The purpose of Senate Bill 391 is to require the Office of Youth Service (OYS) to coordinate a two-year safe places for youth pilot program, including a network of safe places where youth can access safety and obtain advice, guidance, programs, and services. The bill also establishes and funds position for youth program coordinator.

OFFICE'S POSITION: The OYS supports the intent of S.B. 391, Relating to Youth, but requests that any appropriation not affect the priorities in the Executive Biennium Budget.

The OYS currently procures programs and services across the state to assist atrisk youth and their families in navigating through the system in order to engage in needed services through outreach and advocacy. In addition, the OYS funds 24-hour short term residential emergency shelters for youth in crisis. Walk-ins are accepted and no prior approval is required. S.B. 391 would expand our current efforts in reaching atrisk youth.

Aloha Chair Chun Oakland, Vice-Chair Green, and members of the Senate Committee on Human Services. My name is Kukunaokalā Yoshimoto, and I am a graduate student at the Myron B. Thompson School of Social Work at the University of Hawaii at Mānoa. I am also the 'Ohana Program Specialist at Hui Mālama O Ke Kai. I am here to testify in **support of SB 391 Relating to Youth**, particularly as it relates to the establishment of a coordinator position as well as the implementation of a pilot program where youth have access to various support services, resources, guidance, and advice where as they otherwise would not have anywhere to go and no one to turn to in times of crisis.

Having had some years of experience as an at-risk youth as well as working with atrisk youth, it is apparent to me how important and needed this type of service is. Thinking back at times in my life where having a Safe House for Youth would have been a crucial resource, I can see how this initiative could have a positive impact on the youth of Hawaii as well as the criminal justice system in Hawaii. By providing an all-encompassing service model while utilizing and building onto already existing programs, agencies, and organizations, the pilot program can start from a solid foundation of community partnerships and will have the ability to grow into a network of collaborative entities that have the best interest of the youth at heart.

Providing these types of intervention services and resources, which had been identified by Hawai'i's youth through the 2012 Youth Summit, could in theory reduce the number of youth that become involved with the justice system. The Youth Safe House working group has had quite a bit of time to consider similar existing models that can be found on the U.S. mainland through which we were able to come up with an appropriate model for our state.

I am again, strongly in support of SB 391 Relating to Youth and hope that you all take this initiative into further consideration at this time. Mahalo for your time and allowing me to testify this afternoon.
