### Making an Appropriation for the Native Hawaiian Hospitality Association

The Hawai'i Tourism Authority (HTA) opposes S.B. 487, which makes a grant to the Native Hawaiian Hospitality Association (NaHHA) for its tourism-related programs.

As a policy-making board, the Authority's board is empowered to make and execute contracts to engage the services of consultants to carry-out its functions under the law, subject to the availability of funds. As such, HTA's board has adopted the Tourism Strategic Plan, which includes in its objectives strengthening the relationship between the visitor industry and the Hawaiian community, nurturing the Hawaiian culture, and supporting Hawaiian programs and cultural practitioners, craftsmen, musicians and artists. Any Hawaiian organization, nonprofit organization, artists and cultural practitioners engaging in promoting Hawaiian culture can submit a proposal to the HTA to develop and implement tourism-related Hawaiian cultural promotional training programs.

The HTA continues to work together with NaHHA and supports their vision to "perpetuate an authentic spirit of aloha and Hawaiian culture in hospitality industry planning, promotion and product development." For the upcoming fiscal period, HTA has budgeted \$325,000 for its Hawaiian culture initiative, which includes incorporating the elements of the native Hawaiian culture into all HTA programs and leveraging visitor industry resources to help perpetuate the Hawaiian culture. As part of this initiative, NaHHA has received over \$3 million for its services and programs.

We do not feel that S.B. 487 is necessary, because what it attempts to achieve is already possible under the existing law. If the legislature wants to fund NaHHA, it should come out of the general fund.
