Chair Taniguchi, Vice Chair Kahele, and members of the Senate Committee on Higher Education, thank you for this opportunity to provide testimony in support of this bill, SB 490, to amend Chapter 457-9, Hawai'i Revised Statutes, to require the Hawaii State Center for Nursing ("Center for Nursing") survey for biennial nurse license renewal. This would enable the Center for Nursing to have 100% of the Hawai'i nurse licensee population participate. The reason for this request is based on a series of problems with participation rates. For example, in 2011 only 23.2% or 4,925 nurses completed the online survey. A return rate under 30%, as you know, does not represent the nursing population and therefore data can be generalized. This problem made it necessary for the Center to spend about \$25,000 sending out a paper survey which added another 2,443 nurse participants or an additional 11.5% to secure the minimal data requirement (34.7%) for analysis of workforce reporting. A higher rate of return on workforce surveys is critical to accurate data analysis and projections. Accurate workforce data has never been more critical as health care reform is underway at both the state and national levels. This request is not meant to be punitive in anyway. This is not a long survey and takes less than ten minutes to complete. We are not suggesting licensure be denied if the survey is not completed. However we are trying to ensure the nursing workforce is accurately reported.

Further, it requires the Professional and Vocational Licensing Division of the Department of Commerce and Consumer Affairs to collaborate with the Center for Nursing by rendering assistance and cooperation by sharing nurse licensee:

- contact information, including but not limited to, email addresses, to enable: conduct research and obtain nursing-related;
- mobilize and connect Hawaii's diverse health care stakeholders and the nursing community;
- provide nurses and stakeholders with information which addresses Hawaii's and the Nation's most pressing health care challenges; i.e., access and quality in the midst of increasing cost; and
- provide models and programs that offer guidance in utilizing nurses more effectively and preparing nursing for the future (including nurses role in the implementation of the Affordable Care Act.

At the October 4, 2012 Board meeting, representatives from the Center did address the Board regarding the workforce survey and the online nurse renewal process. Previously, the Center's workforce survey was available for nurses who renewed their license online, and was located at the end of the renewal process. At this meeting, the Center requested that the workforce survey be placed at the beginning of the online renewal process. The Board agreed to make the workforce survey available at the beginning and end of the online renewal process. At this meeting, the representatives also stated that they would like the workforce survey to be required in order for a nurse to renew his/her license. The Board, at this meeting, voiced their concerns for mandating a nurse to complete a survey in order to renew his/her license, including but not limited to the possible implications should nurses fail or refuse to complete the survey.

The Board, when it meets, will consider the amendment proposed on page 5, lines 11 - 14, requiring a nurse to complete the Center's survey in order to renew his/her license.

My name is Celia Suzuki, Licensing Administrator for the Professional and

Vocational Licensing Division of the Department of Commerce and Consumer Affairs.

The Division appreciates the opportunity to provide comments on Senate Bill No. 490,

Relating to Nursing, that would require the Hawaii State Board of Nursing ("Board") and

the Professional and Vocational Licensing Division ("PVL"), Department of Commerce

and Consumer Affairs ("Department"), to provide nurse license contact information to

the Hawaii State Center for Nursing ("Center") so that the Center may use this

information to contact the nurse licensee to obtain workforce data to be used to

determine the current and future trends of the nursing workforce. This bill would also

require that nurse licensees complete the Center's workforce survey in order to renew their licenses, making this a renewal requirement.

The Board has submitted its own testimony so I will be addressing the impacts that the bill may have on PVL.

SECTION 2, on pages 3-4, lines 11-21 and 1-15 respectively:

- This measure requires PVL to provide the Center with "nursing-related data." We strongly believe that this term is too broad and should be more narrowly defined, as it is will create confusion on what kind of information must be provided.
- There appears to be no necessity for a memorandum of understanding between PVL and the Center, as the various tasks that must be performed are clearly listed in the bill.
- The measure requires PVL to provide email addresses. Currently, we do not require nurses, or any other professional or vocational licensee, to provide an email address as part of the licensing requirements; therefore, email addresses are not maintained in the PVL database.
- When a licensee renews a license via our online renewal process, the email address is used to "confirm" payment of the renewal fees, and for no other purpose. This purpose is disclosed to the licensee; therefore, licensees currently have an expectation of privacy regarding their email address.
- If the Center wants access to contact information from PVL, the statute should clearly specify the type of information, as HRS section 92F-12(b)(2) requires agencies to disclose government records which, pursuant to federal or state law,

are <u>expressly authorized to be disclosed to the person requesting access</u>. This would allow PVL clear authority to disclose the information.

- It should be clarified that any information will be provided "upon request", so that the bill is not misinterpreted to mandate the reporting of unsolicited information.
- The measure requires PVL to perform research, analysis, and report functions
 which it is not equipped to provide. Our primary duty is to protect the public by
 determining if applicants are qualified for licensure. PVL does not have the
 manpower or resources to comply with this mandate, nor do we believe that it is
 within our realm of responsibility.

SECTION 3, on page 5, lines 11 – 14:

 We oppose the requirement that completion of the survey is necessary for renewal of the license, as it does not enhance the licensee's competency or quality of care. Furthermore, the possibility of nurses failing or refusing to complete the workforce survey would result in the non-renewal of the license. This would gravely impact the nursing workforce and possibly create a nursing shortage in this State.

PVL, DCCA, and the Board are aware of the Center's "mission" to collect the workforce data for nurses and have been working on solutions to provide the Center with as much information as possible in compliance with the Hawaii Revised Statutes Chapter 92F, the Uniform Information Practices Act. We are attempting to modify our renewal and initial license nurse applications to include questions for the applicant/licensee asking permission to release their information to the Center. of the online renewal and to also include a link to the Center's survey on the Board's

SB 490 RELATING TO NURSING

Chair Taniguchi, Vice Chair Kahele, and Members of the Senate Committee on Higher Education, thank you for this opportunity to provide testimony.

I am strongly opposed to SB490 for several reasons. The wording in this bill, that I am opposed to is: shall be required as part of the license renewal requirements under subsection 457-9(a). "No other state in the US makes this survey a "Mandatory" requirement for licensing! I've checked, as have others! I understand that the information that the Center for Nursing would like is valuable and useful and that sharing information with & from the Hawaii Board of Nursing and other higher educational facilities is advantageous for the reasons stated in this bill. However, to make this a requirement for licensing is plain wrong! Many states present a survey at the time of licensing, but they do not make this a mandatory requirement, but a request. My American Association of Nurse Anesthetist (AANA), asks its member to fill out a survey every year our fees, come due for membership. They have 96% participation by our members in completing this survey. I believe that the Nurses of Hawaii would be just as diligent. This information would be available to the Center for Nursing, the BON, and others. I'm sure that you know that information, "on line", is sometimes lost. We all have had information or communication that ends up in cyber space and never gets to the receiver. I can easily see this happening to some nurse, and surprisingly they are delinquent in getting a license, because the Center didn't receive the survey. This could be a major problem and unlawful as the nurse is now working without a license. In addition, the Center for Nursing has sole discretion as to what questions they wish to ask. There is no "over - sight" as to the questions being asked. Some of this information is very private and may be very privileged information to the Nurse. Haven't you had times been asked for information and you don't really want to give that information to the person or group whom is asking for it; as it was too personal! I ask that you not pass this bill for the reasons stated. It's amazing to me, Senators, that we have teachers whom are not required to have random drug screening for employment and licensing, but a nurse can refused his or her license to practice because a survey is not completed.
