Re: S.B. No. 492, S.D. 2 Relating to Tobacco Products

The Department of Taxation (Department) **appreciates the intent** of S.B. 492, S.D. 2 and offers for the following information and comments for your consideration. The Department defers to the Department of Health on the merits of the bill's effect on health.

S.B. 492, S.D. 2 changes the current tax rate on tobacco products other than cigarettes, little cigars and large cigars from 70% of the wholesale price to an unspecified percentage of the wholesale price. This measure also remits the entirety of the taxes collected on such tobacco products to the Hawaii Cancer Research Special Fund.

Due to the required changes to the form, the Department respectfully requests that the effective date be no earlier than January 1, 2014.

The tax rate being amended in this measure is unspecified. Assuming, however, the rate were 102% as set forth in S.D. 1 and the bill became effective January 1, 2014, the Department estimates this measure would result in a decrease to the general fund of \$5.9 million per year. There would be an estimated gain of \$7.8 million per year to the Hawaii Cancer Research Special Fund.

SB 492, SD 2 – RELATING TO TOBACCO PRODUCTS Cory Chun, Government Relations Director – Hawaii Pacific American Cancer Society Cancer Action Network

Thank you for the opportunity to provide written comments in support of SB 492, SD 2, which increases the excise tax on other tobacco products beginning January 1, 2014.

The American Cancer Society Cancer Action Network (ACS CAN), the advocacy affiliate of the American Cancer Society, is the nation's leading cancer advocacy organization. ACS CAN works with federal, state, and local government bodies to support evidence-based policy and legislative solutions designed to eliminate cancer as a major health problem.

Other tobacco products, including smokeless tobacco products such as snus and dissolvable strips, orbs, and sticks, are part of a new series of emerging tobacco products currently being promoted by the tobacco industry as less harmful, more convenient, and more socially acceptable alternatives to traditional cigarettes. However, there is no scientific evidence that smokeless tobacco products are safe and the use of smokeless tobacco products is not considered a safe substitute for, or an effective means of, quitting tobacco use altogether.

The purpose of this measure is to ensure tax parity between cigarettes and other tobacco products. ACS CAN supports eliminating price discrepancies between cigarettes and other tobacco products (OTPs) by increasing the tax on a package of OTPs to an equivalent percentage of the manufacturer's price as the tax on cigarettes.

ACS CAN would like to note that the Senate Committee on Health increased the wholesale price on other tobacco products to 102% of the wholesale price, which is the recommended level in order to ensure parity with the current tax on cigarettes. For these reasons, we urge the committee to move this measure forward.
