Chair Takai, Vice Chair Ito, and members of the committee:

My name is Charles Ota and I am the Vice President for Military Affairs at The Chamber of Commerce of Hawaii (The Chamber). I am here to state The Chamber's **support of Senate Bill No. 506, HD2**, Relating to Professional and Vocational Licensing.

The measure clarifies that licensing authorities that consider relevant education, training, or service of a military veteran applicant and determine the applicant meets or exceeds the requirements for licensure in Hawaii shall accept the results of the passage of a national or regional exam accepted by statute or rule in a specific licensing area or equivalent as determined by the licensing authority. Requires a certificate or evidence satisfactory to the licensing authority of having passed a national or regional exam or the equivalent to be provided to the licensing authority.

We agree that the amendments proposed would clarify the steps needed to expeditiously process licensure applications submitted by transitioning service members in Hawaii. We further agree that the proposed measure demonstrates Hawaii's continuing commitment to the nationwide effort to facilitate military veteran's transition to post-military service employment. They are in keeping with the desires of the President of the United States and the Secretaries of Defense and Veterans Affairs in placing top priority for the employment of our military veterans. In light of the above, we recommend the measure be approved.

Chair Takai, Vice Chair Ito and Committee Members,

The Department of Hawaii, Veterans of Foreign Wars of the United States (VFW) represents more than 3,800 members in 20 Posts located throughout the State of Hawaii. VFW is a federally chartered national association of soldiers, sailors, marines and airmen who have served the United States of America in wars, campaigns, and expeditions on foreign soil or in hostile waters.

S.B. 506: Clarifies that licensing authorities that consider relevant education, training, or service of a military veteran applicant and determine the applicant meets or exceeds the requirements for licensure in Hawaii shall accept the results of the passage of a national or regional exam accepted by the statute or rule in the specific licensing area or the equivalent as determined by the licensing authority. Requires a certificate or evidence satisfactory to the licensing authority of having passed a national or regional exam or the equivalent to be provided to the licensing authority. (SD2)

This measure will ensure that transitioning veterans leaving active military service will have their documented education, training and experience favorably considered for licensure by licensing authorities subject to chapter 436B, HRS.

VFW Hawaii members are grateful for your efforts to require licensing authorities subject to chapter 436B, HRS, to accept the results of the passage of a national or regional exam, supported by a certificate or evidence satisfactory to those licensing authorities, in their evaluation process toward granting licenses to transitioning veterans.

We urge this Committee to make this measure effective upon its approval by the Governor of Hawaii.

Honorable Chair K. Mark Takai, Vice Chair Ken Ito and members of the House Committee on Veterans, Military, & International Affairs, & Culture and the Arts,

My name is Russel Yamashita and I am the legislative representative for the Hawaii Dental Association (HDA) and its 960 member dentists. I appreciate the opportunity to comment on Senate Bill 506 SD 2 Relating to Professional and Vocational Licensing. This legislation seeks to amend Act 248, SLH 2012, which provided recognition of military training for licensure requirements for professional and vocational licensure in the State of Hawaii, by extending the recognition of another state's licensure, if that state's licensure requirements meets or exceeds those established by the Hawaii licensing board or commission. It also provides that the Hawaii board or commission would have to recognize the applicant's national or regional examination, if the other state's licensure requirements are recognized.

This bill is similar to HB 1381 HD 2, which provided similar changes to Hawaii's professional and vocational licensing laws and excluded specific professions, such as medical doctors, dentists, and CPAs. As stated in testimony on this bill and HB 1381, the HDA believes that these measures be deferred this legislative sessions in order for all those professions and vocational license holder to be permitted to discuss this matter before any significant changes to Hawaii's licensure laws takes place on such a large scale.
