Chair Takai, Vice Chair Ito and Committee members:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony in support of the concepts in Senate Bill 540 (SSCR 765).

This measure ensures Hawaii's eligibility requirements for the burial of members of the United States Armed Forces and their dependents conforms to the criteria established by the United States Department of Veterans Affairs (VA) regarding eligibility for burial in a national or state cemetery. Without approval of this Bill and subsequent amendment to the Hawaii Revised Statue, VA National Cemetery Administrators could preclude providing matching federal dollars for future Capital Improvement Projects or improvements for our aging cemeteries. Furthermore, VA could request restitution of funding previously provided for these programs if the residency requirement is enacted or enforced.

The OVS supports the concepts and intent of this bill as long as its implementation does not impact or replace the priorities set forth in the Executive Biennium Budget for Fiscal Years 2013-2015.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families in support of SB 540, (SSCR 765).

## Testimony in Support of SENATE BILL 540 Relating to Veterans Before the Senate Committee on Veterans, Military, & International Affairs, & Culture and the Arts Hearing On Wednesday, March 20, 2013, 8:30 A.M. In Conference Room 312

Chair Takai, Vice Chair Ito, and Committee Members,

The Department of Hawaii, Veterans of Foreign Wars of the United States (VFW), represents more than 3,800 members in 20 Posts located throughout the State of Hawaii. VFW is a federally chartered national association of soldiers, sailors, marines and airmen who have served the United States of America in wars, campaigns, and expeditions on foreign soil or in hostile waters.

S.B. 540 Makes permanent provisions relating to residency requirements for the burial in veterans cemeteries of armed service members and their dependents.

Act 307, Session of 2012, amended Section 363-5 H.R.S. to <u>remove</u> the residency requirement for burial in veterans cemeteries; amended the eligibility requirements of Section 363-5 in accordance with current Veterans Affairs and National Cemeteries Administration Regulations; and repealed Section 363-7 H.R.S. that had given county councils discretion on whether to allow burial of nonresident servicemen and dependents. Act 307 was effective "upon its approval provided that on June 30, 2015, this Act shall be repealed, and section 363-5 [H.R.S.] shall be reenacted in the form in which it read on the day prior to the effective date of [Act 307]." S.B.540 would <u>delete</u> this proviso, thereby making permanent NO residency requirements for burial in veterans cemeteries on all islands of the State of Hawaii.

VFW Hawaii members fully support this measure that will completely <u>repeal the pending</u> <u>reenactment of provisions</u> to permit only resident service members, veteran and dependent to be buried in State veterans cemeteries.
