# TESTIMONY ON SENATE BILL NO. 548, S.D. 1, H.D. 1, RELATING TO TELEMEDICINE.

TO THE HONORABLE DELLA AU BELATTI, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Celia Suzuki, Licensing Administrator for the Professional and

Vocational Licensing Division, Department of Commerce and Consumer Affairs

("Department"). The Department appreciates the opportunity to submit comments on

Senate Bill No. 548, S.D. 1, H.D. 1, Relating to Telemedicine.

The purpose of this measure is to enhance accessibility to medical services for

members of the armed services in Hawaii by allowing certain individuals to provide

direct telemedicine support or services to neighbor island beneficiaries within a Hawaii

National Guard armory on the islands of Kauai, Hawaii, Molokai, and Maui.

For your information, Representative K. Mark Takai, Chair of the Committee on Veterans, Military, and International Affairs, and Culture and the Arts, has requested that the Department, the Board of Psychology, the Marriage and Family Therapists Licensing Program, the Mental Health Counselors Licensing Program, and the Tripler Army Medical Center ("Tripler") continue its discussion regarding this matter. Representative Takai has tasked us to draft language which would exempt from the appropriate licensing laws psychologists, marriage and family therapists, and mental health counselors employed by the United States Department of Defense and credentialed by Tripler from the licensing requirements to practice the respective scopes of practice in the State while providing services to neighbor island beneficiaries within a Hawaii National Guard armory on the island of Kauai, Hawaii, Molokai, and Maui.

Given this information, the Department, while supportive of Representative Takai's wishes, would like to express its concern with the title of the bill "Relating to Telemedicine", if it were revised to include psychologists, marriage and family therapists, and mental health counselors. The title "Relating to Telemedicine" should only apply to those who are legally able to engage in the practice of medicine (e.g. allopathic and osteopathic physicians).

In accordance with the State of Hawaii Constitution, Article III, Section 14, each law shall embrace but one subject, which shall be expressed in its title. A title must include a distinct reference to the subject matter to which it relates and also cover but one subject. Therefore, the scope of the title telemedicine cannot be narrower than the scope of the subject matter. Thank you for the opportunity to provide comments on Senate Bill No. 548,

Chair Belatti, Vice Chair Morikawa, and Committee Members,

The Department of Hawaii, Veterans of Foreign Wars of the United States (VFW), represents more than 3,800 members in 20 Posts located throughout the State of Hawaii. VFW is a federally chartered national association of soldiers, sailors, marines and airmen who have served the United States of America in wars, campaigns, and expeditions on foreign soil or in hostile waters.

S.B. 548 Exempts from licensing requirement to practice medicine in the State any commissioned medical officer employed by the U.S. Department of Defense, who is credentialed by Tripler Army Medical Center, while providing direct telemedicine support or services to neighbor island beneficiaries within a Hawaii national guard armory on the island of Kauai, Hawaii, Molokai, or Maui. Effective July 1, 2050. (SB548 HD1)

This measure will ensure that service members seeking medical services at Hawaii National Guard Armories on the islands of Kauai, Hawaii, Molokai, or Maui can be furnished telemedicine support by fully qualified medical and behavioral health professionals at Tripler Army Medical Center. VFW Hawaii members are grateful for your efforts to extend telemedicine support from health professionals credentialed at Tripler Army Medical Center to service members seeking medical services at Hawaii National Guard Armories on the islands of Kauai, Hawaii, Molokai, or Maui.

VFW Hawaii members urge this Committee to make this measure effective upon its approval by the Governor of Hawaii.
