RE: SB 548 SD1 Relating to Telemedicine Chair Takai, Vice Chair Ito, and Members of the Committee:

Thank you for the opportunity to submit comments in opposition to certain language in this measure.

The Hawaii Psychiatric Medical Association applauds the legislature's efforts to improve access to good medical care, as well as to good psychological and marital therapy, especially in rural areas of Hawaii. Telemedicine and Telebehavioral Health are in practice already in many states including here. However, as written, SB 548 SD1 blurs a significant distinction between the two.

Behavioral health professionals include marriage and family therapists, mental health counselors, and psychologists. SB 548 SD1 includes language exempting behavioral health specialists from licensing requirements to practice medicine, which could be misconstrued as to allow these professionals to practice not just counseling, but medicine, remotely, despite having no medical training nor license.

Given the potential for such an unintended consequence, we respectfully request that the committee remove references to behavioral health specialists, or that this measure be held.

Testimony in Support of SENATE BILL 548 Relating to Telemedicine Before the House Committee On Veterans, Military, & International Affairs, & Culture and the Arts Hearing On Wednesday, March 13, 2013, 8:30 A.M. In Conference Room 312

Chair Takai, Vice Chair Ito and Committee Members,

The Department of Hawaii, Veterans of Foreign Wars of the United States (VFW) represents more than 3,800 members in 20 Posts located throughout the State of Hawaii. VFW is a federally chartered national association of soldiers, sailors, marines and airmen who have served the United States of America in wars, campaigns, and expeditions on foreign soil or in hostile waters.

S.B. 548: Exempts from licensing requirement to practice medicine in the State any commissioned medical officer or commissioned or civilian behavioral health professional employed by the U.S. Department of Defense, who is credentialed by Tripler Army Medical Center, while providing direct telemedicine support or services to neighbor island beneficiaries within a Hawaii national guard armory on the island of Kauai, Hawaii, Molokai, or Maui. Specifies that those civilian behavioral health professionals employed by the U.S. Department of Defense and who are credentialed by Tripler Army Medical Center must also be otherwise licensed as marriage and family therapists under chapter 451J, HRS, mental health counselors under chapter 453D, HRS, or psychologists under chapter 465, HRS. (SD1)

This measure will ensure that service members seeking medical services at Hawaii National Guard Armories on the islands of Kauai, Hawaii, Molokai, or Maui can be furnished telemedicine support by fully qualified medical and behavioral health professionals at Tripler Army Medical Center.

VFW Hawaii members are grateful for your efforts to extend telemedicine support from health professionals credentialed at Tripler Army Medical Center to service members seeking medical services at Hawaii National Guard Armories on the islands of Kauai, Hawaii, Molokai, or Maui.

We urge this Committee to make this measure effective upon its approval by the Governor of Hawaii.
