My name is Kyle Datta and I am General Partner of the Ulupono Initiative, a Hawai'i-based impact investment firm that strives to improve the quality of life for the people of Hawai'i by working toward solutions that create more locally grown food, increase renewable energy, and reduce/recycle waste.



Dear Senate Committee on Agriculture,



I am writing this letter in support of Senate Bill 592, which would create funds to support agricultural programs such as 4-H, the University of Hawai'i at Manoa, and FFA. My name is Makana Agcaoili, and I am serving as the Hawai'i FFA State President. Being the State President has proliferated into a difficult task to plan activities for the hundreds of members with such little money. Many other states support their state organizations through providing adequate funds because they understand just how important this organization is, and the tremendous impact that the National FFA Organization has on shaping and creating leaders.

The National FFA Organization is the largest and oldest student led organization in the United States. For over eighty years, FFA has created leaders such as President Carter and amazing singers like Taylor Swift. FFA is able to create such strong and diverse leaders through its combination of classroom and "real world" experience, allowing members to practice what they learn in the class in a working environment. This duality builds upon each other and creates students who are able to work better in the classroom and solve technical problems in life. One specific way this is done is through the many competitions available to members.

Members are able to take what they learn in their Natural Resource classes and use those skills and information to compete in Career Development Events (CDEs) that focus on activities that they will need to be able to do in the future. Some of these CDEs are team based such as Parliamentary Procedure, which teaches the importance of learning how to run a meeting using Robert's Rules of Order. There are also individual events like Extemporaneous Public Speaking, where members need to be able to write a short speech within half an hour, and events that focus on agriculture itself: such as Plant Identification, Agricultural Demonstration, and vegetable and animal judging. While these activities vary, they all seek innovative solutions for local and national methods of farming. However, due to the lack in support, it is difficult for our state association to create new events that will challenge and prepare our members to address the issues arising from the new procedures in technology and farming today.

The Hawaii FFA State Association is underfunded. While there are several donors and fundraisers throughout the year, there isn't enough support as there are in other states. There is only enough funds to plan one large state wide event. Programs are unable to expand due to the limited amount of funds, and opportunities such as the National FFA Convention are nearly impossible for everyday members. However, all of that can change with further support from the government.

Our nation was created by farmers. Farmers made up the militias that fought against Britain and gained the United States its independence. When anyone from Hawaii flies over the continental U.S. and looks out the window, the patch work quilt of farmland appears as far as the eye can go. Agriculture began our nation, links our nation, and strengthens it, and FFA strengthens and prepares those individuals who will become the new farmers and leaders.
