As an undergraduate student at the University of Hawai'i at Mānoa and as the Campus Center Board Secretary, I am grateful to being given the opportunity to testify Senate Bill 603. I am testifying in support of S.B. No. 603 that authorizes the issuance of GO bonds that would retire the revenue bond debt incurred by the University of Hawai'i for the University of Hawai'i at Mānoa Campus Center Renovation and Expansion (CCRE) Project.

The Campus Center Board (CCB) provides governance for the Campus Center as well as its programs. CCB ensures that the Campus Center supplies the necessary facilities, programs, and services to the campus community. The Campus Center Complex includes Campus Center, Hemenway Hall, and the upcoming Recreation Center. All together, it serves as a community center that offers an array of options that support campus life and education.

The Campus Center Renovation and Expansion Project plan came about in Fall 2005. It was the idea the CCB envisioned to meet the needs for its constituents. The CCRE Project includes the structuring of the Recreation Center along with general repairs and modifications to the Campus Center building and Hemenway Hall. These actions are necessary to fulfill the requirements as an effective and successful university to the campus population. However, in order to accomplish these goals, student fees are being raised due to the fact that the financial plan alone is unable to sustain the expenses.

Retiring the revenue bond debt with the conversion to GO bonds would financially relieve University of Hawai'i students, increase the pace of improvements being made, and allow us to continue to support the needs of our constituents.
